The Grand Jury charges that:

COUNT 1

Beginning at a time unknown and continuing until on or about July 20, 2011, in the Eastern District of Louisiana, and elsewhere, the defendants, **CHRISTIEN SCOTT**, **JAMES SELF** and **TULLIE WHITEN**, did knowingly and intentionally combine, conspire, confederate and agree with other persons known and unknown to the Grand Jury, to distribute and to possess with the intent to distribute twenty-eight grams or more of cocaine base ("crack"), a Schedule II narcotic drug

controlled substance, and a quantity of marijuana, a Schedule I drug controlled substance, in violation of Title 21, United States Code, Sections 841(a)(1), 841(b)(1)(B) and 841 (b)(1)(D); all in violation of Title 21, United States Code, Section 846.

COUNT 2

On or about July 20, 2011, in the Eastern District of Louisiana, the defendants, **CHRISTIEN SCOTT**, **JAMES SELF** and **TULLIE WHITEN**, did knowingly and intentionally possess with the intent to distribute twenty-eight grams or more of cocaine base ("crack"), a Schedule II narcotic drug controlled substance, in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(B), and Title 18, United States Code, Section 2.

COUNT 3

On or about July 20, 2011, in the Eastern District of Louisiana, the defendants, **CHRISTIEN SCOTT**, **JAMES SELF** and **TULLIE WHITEN**, did knowingly and intentionally possess with the intent to distribute a quantity of marijuana, a Schedule I drug controlled substance, in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(D), and Title 18, United States Code, Section 2.

COUNT 4

On or about July 20, 2011 in the Eastern District of Louisiana, the defendants, **CHRISTIEN SCOTT** and **JAMES SELF**, did knowingly possess a firearm, to wit: a Rossi .38 Special handgun, bearing serial number D451776, in furtherance of a drug trafficking crime for which they may be prosecuted in a court of the United States, to wit: possession with intent to distribute a quantity of cocaine base and possession with intent to distribute marijuana, in violation of Title 21, United States Code, Section 841(a)(1) as charged in Counts 2 and 3 of this indictment; all in violation of

Title 18, United States Code, Sections 924(c)(1) and Title 18 United States Code, Section 2.

NOTICE OF FORFEITURE

- 1.) The allegations of Counts 1 through 3 of this Indictment are realleged and incorporated by reference as though set forth fully herein for the purpose of alleging forfeiture to the United States of America pursuant to the provisions of Title 21, United States Code, Section 853.
- 2.) As a result of the offenses alleged in Counts 1 through 3, the defendants, CHRISTIEN SCOTT, JAMES SELF and TULLIE WHITEN, shall forfeit to the United States pursuant to Title 21, United States Code, Section 853, any and all property constituting or derived from any proceeds the defendants obtained directly or indirectly as a result of the said violations and any and all property used or intended to be used in any manner or part to commit or to facilitate the commission of the violations alleged in Counts 1 through 3 of this Indictment.
- 3.) If any of the property subject to forfeiture pursuant to Paragraph 2 of this Notice of Forfeiture, as a result of any acts or omissions of the defendants, CHRISTIEN SCOTT, JAMES SELF and TULLIE WHITEN
 - a.) cannot be located upon the exercise of due diligence;
 - b.) has been transferred or sold to, or deposited with, a third person;
 - c.) has been placed beyond the jurisdiction of the Court;
 - d.) has been substantially diminished in value; or
 - e.) has been commingled with other property which cannot be subdivided without difficulty;

it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p), to seek

forfeiture of any other property of said defendant up to the value of the above forfeitable property.

All in violation of Title 21, United States Code, Section 853.

NOTICE OF GUN FORFEITURE

- 1.) The allegation of Count 4 of this indictment is realleged and incorporated by reference as though set forth fully herein for the purpose of alleging forfeiture to the United States of America pursuant to the provisions of Title 18, United States Code, Section 924 (d)(1), Title 28, United States Code, Section 2461 and Title 21, United States Code, Section 853.
- 2.) As a result of the offense(s) alleged in Count 4, defendants, **CHRISTIEN SCOTT** and **JAMES SELF**, shall forfeit to the United States pursuant to Title 18, United States Code, Section 924(d)(1), Title 28 United States Code, Section 2461, and Title 21, United States Code, Section 853, any firearm or ammunition, which was involved in or used in a knowing violation of Title 18, United States Code, Section 922, as alleged in Count 4 of the Indictment.
- 3.) If any of the property subject to forfeiture pursuant to Paragraph 2 of this Notice of Forfeiture, as a result of any acts or omissions of the defendants, CHRISTIEN SCOTT and JAMES SELF:
 - a.) cannot be located upon the exercise of due diligence;
 - b.) has been transferred or sold to, or deposited with, a third person;
 - c.) has been placed beyond the jurisdiction of the Court;
 - d.) has been substantially diminished in value; or
 - e.) has been commingled with other property which cannot be subdivided without difficulty;

it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p), to seek forfeiture of any other property of said defendants up to the value of the above forfeitable property.

All in violation of Title 18, United States Code, Sections 922 and/or 924(c)(1) and 924(d)(1).
