The Grand Jury charges that:

COUNT 1

On or about January 3, 2012, in Orleans Parish, in the Eastern District of Louisiana, the defendant, **ANTONIO GUILLERMO MONTES-JUAREZ, a/k/a Nery Artemio Juarez-Campos, a/k/a Nery A. Juarez, a/k/a Nary Juarez-Campos, a/k/a Nery A. Campos, a/k/a Antonio Flores**, an alien, was found in the United States after having been officially deported and removed therefrom to Mexico on or about February 15, 2005 at or near Brownsville, Texas, and

without the Attorney General of the United States or his designated successor, the Secretary of the Department of Homeland Security, as provided for in Title 6, United States Code, Sections 202(3), 202(4), and 557, having expressly consented to the defendant's reapplication for admission into the United States; all in violation of Title 8, United States Code, Section 1326(a).


NOTICE OF SENTENCING ENHANCEMENT

Now comes the United States of America, by and through Jim Letten, the United States Attorney for the Eastern District of Louisiana, to give notice that on or about October 3, 2003, in the Circuit Court of Fairfax County, Virginia, the defendant, **ANTONIO GUILLERMO MONTES-JUAREZ, a/k/a Nery Artemio Juarez-Campos, a/k/a Nery A. Juarez, a/k/a Nary Juarez-Campos, a/k/a Nery A. Campos, a/k/a Antonio Flores**, was convicted of abduction. Because of this aggravated felony conviction, if the defendant is convicted for a violation of Title 8, United States Code, Section 1326(a), the defendant's sentence will be subject to a maximum


sentence of imprisonment for not more than 20 years. Title 8, United States Code, Section 1326(b)(2).
