## **INDICTMENT**

#### THE GRAND JURY CHARGES THAT:

## **COUNT ONE**

Beginning on or about June, 2011, and continuing to on or about September 20, 2011, in Jasper County, in the Western District of Missouri, and elsewhere, **LAVAR D. BEARD, ASHLEY HENSON, JASON E. HIRSHEY, HALEY J. FERGUSON** and **BRIAN D. FERGUSON,** defendants, did knowingly and intentionally conspire and agree with each other and with persons known and unknown to the Grand Jury, to distribute 100 grams or more of a mixture or substance containing a detectable amount of heroin, a Schedule I controlled substance, contrary to the provisions of Title 21, United States Code, Section 841(a)(1) and (b)(1)(B)(i); all in violation of Title 21, United States Code, Section 846.

## **COUNT TWO**

On or about August 19, 2011, in Jasper County, in the Western District of Missouri, **LAVAR D. BEARD**, defendant, did knowingly and intentionally distribute heroin, a Schedule I controlled substance, and as a result of the use of this heroin, Ryan Cockrell died, all in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

## **COUNT THREE**

On or about August 23, 2011, in Jasper County, in the Western District of Missouri, **LAVAR D. BEARD,** did knowingly and intentionally distribute heroin, a Schedule I controlled substance in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

#### **COUNT FOUR**

On or about August 26, 2011, in Jasper County, in the Western District of Missouri, **LAVAR D. BEARD**, did knowingly and intentionally distribute heroin, a Schedule I controlled substance in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

## **COUNT FIVE**

On or about August 30, 2011, in Jasper County, in the Western District of Missouri, **LAVAR D. BEARD**, defendant, did knowingly and intentionally distribute heroin, a Schedule I controlled substance in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

## **COUNT SIX**

On or about August 31, 2011, in Jasper County, in the Western District of Missouri, **ASHLEY HENSON**, defendant, did knowingly and intentionally distribute heroin, a Schedule I controlled substance in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

#### **COUNT SEVEN**

On or about September 9, 2011, in Jasper County, in the Western District of Missouri, **LAVAR D. BEARD**, defendant, did knowingly and intentionally distribute heroin, a Schedule I controlled substance in violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(C).

#### **COUNT EIGHT**

On or about September 20, 2011, in Jasper County, in the Western District of Missouri, **LAVAR D. BEARD**, defendant, knowingly and intentionally possessed with intent to distribute a mixture or substance containing a detectable amount of heroin, a Schedule I controlled substance, in violation of Title 21, United States Code, Sections 841(a)(1) and (b)(1)(C).

## **COUNT NINE**

On or about September 20, 2011, in Jasper County, in the Western District of Missouri, **LAVAR D. BEARD**, defendant, having been convicted of a crime which is punishable by imprisonment for a term exceeding one year, knowingly possessed, in and affecting commerce, firearms, those are Ruger, Model Security Six, .357 caliber revolver, S/N 160-96860, Raven Arms, Model MP25, .25 caliber pistol, S/N 750064, and ammunition, that is six rounds of Remington, .25 caliber ammunition, all in violation of Title 18, United States Code, Sections 922(g)(1) and 924(a)(2).
