



WILLIAM C. MURPHY : CRIMINAL COMPLAINT


I, Stephen J. Jamison, being duly sworn, state the following is true and correct to the best of my knowledge and belief. On or about March 25, 2009, in Passaic County, in the District of New Jersey, and elsewhere, defendant William C. Murphy:

did knowingly possess material that contained at least three images of child pornography, as defined in Title 18, United States Code, Section 2256(8), which images were mailed and shipped and transported using any means or facility of interstate and foreign commerce and in and affecting interstate and foreign commerce by any means, including by computer, and that were produced using materials that have been mailed, and shipped and transported in and affecting interstate and foreign commerce by any means, including by computer, in violation of Title 18, United States Code, Section 2252A(a)(5)(B).

I further state that I am a Special Agent with the Federal Bureau of Investigation, and that this complaint is based on the following facts:

## ATTACHMENT A

I, Stephen J. Jamison, a Special Agent with the Federal Bureau of Investigation, having conducted an investigation and discussed this matter with other law enforcement officers who have participated in this investigation, have knowledge of the following facts:

1. On or about March 25, 2009, law enforcement officers executed a search warrant at a two-story single family house in Haskell, New Jersey 07420 (the "Residence"). William C. Murphy ("defendant Murphy") resided at the Residence. Among the items seized at the Residence was one computer hard drive (the "Computer Hard Drive").

2. On or about March 26, 2009, law enforcement officers conducted a preliminary review of the contents of the Computer Hard Drive. Among the files found on the Computer Hard Drive were approximately 50 images of what appear to be child pornography as defined by Title 18, United States Code, Section 2256(8). Three of the images found on the Computer Hard Drive are described as follows:

- A. **Image One ((Lolitaguy)) Lovely Nymphets Series 016 Vika Set 1 (8Yo) (53 Pics) pthc-lsm.jpg):** This image depicts a naked prepubescent female. She is standing with her right leg extended out to the side with her right toes touching the ground. Her left hand is on her left thigh and her right arm is bent with the back of her hand touching the right side of her face. She is wearing what appears to be a long white pearl necklace which extends down her torso to her legs. She is also wearing what appears to be a white pearl bracelet on her left wrist. There appears to be a chair, which is covered in a blue cloth, behind her. The words "Ukrainian nymphets [www.Ukrainian-Nymphets.com](http://www.Ukrainian-Nymphets.com)" is written in the top left hand corner of the image.
- B. **Image Two (lhv-009-101 - lolitas young 12yr old virgins little child preteens underaged pussy ls-models bd-company.jpg):** This image depicts a naked prepubescent female. She is sitting on what appears to be a tan carpet with her legs spread apart exposing her vagina. She appears to be wearing a purple necklace around her neck. She also appears to be wearing pink and white flowers in her hair. The words "LS Models" appears in the upper left hand corner of the image.
- C. **Image Three (lsm-pthc-lhv-ufo-008.jpg):** This image depicts a naked prepubescent female. She is kneeling on what appears to be a yellowish brown rock. Her left leg is up in the air, and her vagina is exposed. She is wearing what appears to be a pink string bracelet on her right wrist and a seashell bracelet on her right ankle. She is wearing what appears to be a pink hairpiece and white beads in her hair. The words "LS Models" are written in the upper right hand corner of the image.

3. Based upon my education, training and experience, and my discussions with other law enforcement officers, and to the best of my knowledge, the images described in paragraphs 2A through 2C above were produced using materials that were mailed and shipped and transported in and affecting interstate and foreign commerce by any means, including by computer, that is, the images were downloaded from the Internet, based upon, among other things, their location on the Computer Hard Drive.

4. On or about March 25, 2009, defendant Murphy admitted, in substance and in part, that the images of child pornography found on the Computer Hard Drive belonged to him.
