sitting at Trenton, charges:

COUNT ONE
(Bank Robbery)

On or about January 29, 2009, in Ocean County, in the
District of New Jersey, and elsewhere, defendant

PETER A. BIELECKE

by force and violence, and by intimidation, did take and attempt
to take from the person and presence of an employee of the
Provident Bank in Brick, New Jersey approximately \$1,851.00
belonging to, and in the care, custody, control, management, and
possession of Provident Bank, the deposits of which were then
insured by the Federal Deposit Insurance Corporation.

In violation of Title 18, United States Code, Section
2113(a), and Title 18, United States Code, Section 2.

COUNT TWO
(Bank Robbery)

On or about February 5, 2009, in Ocean County, in the District of New Jersey, and elsewhere, defendant

PETER A. BIELECKE

by force and violence, and by intimidation, did take and attempt to take from the person and presence of an employee of the Investor Savings Bank in Brick, New Jersey approximately \$1,385.00 belonging to, and in the care, custody, control, management, and possession of Investors Savings Bank, the deposits of which were then insured by the Federal Deposit Insurance Corporation.

In violation of Title 18, United States Code, Section 2113(a), and Title 18, United States Code, Section 2.

COUNT THREE
(Bank Robbery)

On or about February 12, 2009, in Ocean County, in the District of New Jersey, and elsewhere, defendant

PETER A. BIELECKE

by force and violence, and by intimidation, did take and attempt to take from the person and presence of an employee of the Sovereign Bank in Toms River, New Jersey approximately \$1,435.00 belonging to, and in the care, custody, control, management, and possession of Sovereign Bank, the deposits of which were then insured by the Federal Deposit Insurance Corporation.

In violation of Title 18, United States Code, Section 2113(a), and Title 18, United States Code, Section 2.

COUNT FOUR
(Bank Robbery)

On or about February 19, 2009, in Ocean County, in the District of New Jersey, and elsewhere, defendant

PETER A. BIELECKE

by force and violence, and by intimidation, did take and attempt to take from the person and presence of an employee of the Investor Savings Bank in Lakewood, New Jersey approximately \$1,323.00 belonging to, and in the care, custody, control, management, and possession of Investors Savings Bank, the deposits of which were then insured by the Federal Deposit Insurance Corporation.

In violation of Title 18, United States Code, Section 2113(a), and Title 18, United States Code, Section 2.

COUNT FIVE
(Bank Robbery)

On or about February 27, 2009, in Monmouth County, in the District of New Jersey, and elsewhere, defendant

PETER A. BIELECKE

by force and violence, and by intimidation, did take and attempt to take from the person and presence of an employee of the Garden State Community Bank in Howell, New Jersey approximately \$2,881.00 belonging to, and in the care, custody, control, management, and possession of Garden State Community Bank, the deposits of which were then insured by the Federal Deposit Insurance Corporation.

In violation of Title 18, United States Code, Section 2113(a), and Title 18, United States Code, Section 2.


COUNT SIX
(Bank Robbery)

On or about March 5, 2009, in Middlesex County, in the District of New Jersey, and elsewhere, defendant

PETER A. BIELECKE

by force and violence, and by intimidation, did take and attempt to take from the person and presence of an employee of the Synergy Bank in Old Bridge, New Jersey approximately \$3,000.00 belonging to, and in the care, custody, control, management, and possession of Synergy Bank, the deposits of which were then insured by the Federal Deposit Insurance Corporation.

In violation of Title 18, United States Code, Section 2113(a), and Title 18, United States Code, Section 2.
