Attachment A

- I, Sandra Sanchez, am a Special Agent with the Federal Bureau of Investigation. I have knowledge of the following facts based upon my investigation, review of reports and discussions with other law enforcement personnel and others. All statements herein are set forth in substance and in part:
- 1. Beginning in or around May 2009, a confidential informant ("CI"), with a proven record of reliability and credibility, provided information that defendant RAJAB GOMEZ, a/k/a "Snow," belonged to a criminal street gang known as the "G-Shine Bloods."
- 2. On or about May 27, 2010, the CI, acting under the direction and supervision of law enforcement, telephoned defendant RAJAB GOMEZ, a/k/a "Snow," to purchase a quantity of crack cocaine. The telephone call was consensually audiorecorded and monitored by law enforcement.
- 3. On or about that same day, defendant RAJAB GOMEZ, a/k/a "Snow," and two unidentified co-conspirators ("CC-1" and "CC-2") met with the CI at a prearranged location in Plainfield, New Jersey. At that location, the CI handed defendant GOMEZ approximately \$2,300.00, and defendant GOMEZ, in turn, handed the CI two clear, plastic baggies each containing a white rock-like substance. This transaction was consensually video and audio-recorded.
- 4. The white-rock like substance in each baggie field-tested positive for the presence of cocaine and collectively weighed approximately 80.5 grams. Subsequent laboratory tests indicate that the collective white-rock like substance contained a net weight of 53.9 grams of cocaine base.
