INDICTMENT

The Grand Jury in and for the District of New Jersey,
sitting at Trenton, charges:

COUNT 1
(Conspiracy to Distribute Oxycodone)

From in or about January 2009 through in or about
December 2010, in Ocean County, in the District of New Jersey and
elsewhere, the defendant,

HASSAN LAHHAM,

did knowingly and intentionally conspire with others to
distribute and to possess with intent to distribute oxycodone, a
Schedule II controlled substance, contrary to Title 21, United
States Code, Sections 841(a)(1) and (b)(1)(C).

In violation of Title 21, United States Code, Section
846.

in the District of New Jersey and elsewhere, the defendant,


