INDICTMENT

The Grand Jury, in and for the District of New Jersey, sitting in Newark, charges:

1. At all relevant times, JPMorganChase, Bank of America, PNC Bank, Sovereign Bank and Grand Bank were domestic financial institutions within the meaning of Title 31, United States Code, Sections 5312 and 5313(a).

2. At all relevant times, Title 31, United States Code, Section 5313(a), and the regulations issued thereunder, required that Currency Transaction Reports be filed for transactions in currency of more than \$10,000, including deposits, withdrawals, exchanges of currency, and other payments and transfers by, through, or to a bank.

3. Between on or about May 1, 2008, and on or about December 31, 2009, in Mercer County, in the District of New Jersey, and elsewhere, the defendant,

SANDRA MASTORIS,

for the purpose of evading the reporting requirements of Title 31, United States Code, Section

5313(a), with respect to such transactions, knowingly structured and assisted in structuring, and attempted to structure and assist in structuring, transactions with domestic financial institutions by causing United States currency totaling in excess of \$700,000 to be deposited in amounts of less than \$10,000, and, as part of a pattern of illegal activity involving more than \$100,000 in a 12-month period between June 27, 2008, and June 27, 2009, knowingly structured, assisted in structuring, and attempted to structure and assist in structuring more than \$100,000.

4. By in or about 2008, Sandra Mastoris had accumulated a cash hoard of approximately up to \$900,000. In the years 2008 and 2009, she then made cash deposits of portions of that cash hoard at five different banks.

5. In 2008, Sandra Mastoris made the following cash deposits on the dates, at the banks and into the accounts as follows:

FORFEITURE ALLEGATION

1. The allegations contained in this Indictment are hereby realleged and incorporated by reference for the purpose of noticing forfeiture pursuant to Title 31, United States Code, Section 5317.

2. Upon conviction of the offense set forth in this Indictment, the defendant,

SANDRA MASTORIS,

shall forfeit to the United States of America, pursuant to Title 31, United States Code, Section 5317(c), all property, real or personal, involved in the offense and any property traceable thereto.

3. If any of the above-described forfeitable property, as a result of any act or omission of the defendant:

- (a) cannot be located upon the exercise of due diligence;
- (b) has been transferred or sold to, or deposited with, a third party;
- (c) has been placed beyond the jurisdiction of the court;
- (d) has been substantially diminished in value; or
- (e) has been commingled with other property which cannot be divided without


difficulty;

it is the intent of the United States, pursuant to, Title 21, United States Code, Section 853; and

Title 31, United States Code, Section 5317(c) to seek forfeiture of any other property of the defendant up to the value of the forfeitable property described in this forfeiture allegation.
