I, Keith Willis, the undersigned complainant being duly sworn, state the following is true and correct to the best of my knowledge and belief. From at least as early as on or about September 17, 2012 through on or about September 18, 2012, in Union County, in the District of New Jersey and elsewhere, defendants ROBERTO RENTAS NEGRON and KELMIT GALLEGO VELAZQUEZ did:

knowingly and intentionally conspire and agree with each other to distribute and possess with intent to distribute 500 grams or more of a mixture or substance containing a detectable amount of cocaine, a Schedule II controlled substance, contrary to Title 21, United States Code, Sections 841(a)(1) and (b)(1)(B), and

In violation of Title 21, United States Code, Section 846.

I further state that I am a Special Agent with the Federal Bureau of Investigation and that this complaint is based on the following facts:



ATTACHMENT A

I, Keith Willis, am a Special Agent with the Federal Bureau of Investigation (“FBI”). I am familiar with the facts set forth herein through my personal participation in the investigation and through oral and/or written reports from other federal agents and law enforcement officers. Where statements of others are related herein, they are related in substance and part. Since this complaint is being submitted for a limited purpose, I have not set forth each and every fact that I know concerning this investigation. Where I assert that an event took place on a particular date, I am asserting that it took place on or about the date alleged.

1. On or about September 17, 2012 a confidential source with a history of reliability and credibility (the “CS”), working at the direction of the FBI, negotiated the purchase of approximately 550 grams of cocaine from ROBERTO RENTAS NEGRON (“NEGRON”).

2. NEGRON advised the CS that an individual working with NEGRON would deliver the cocaine to the CS at an agreed location.

3. Thereafter on or about September 18, 2012, while under audio and video surveillance by law enforcement, the CS traveled to the previously agreed location in Union County, New Jersey, to purchase the cocaine. After the CS arrived at the agreed location, KELMIT GALLEGU VELAZQUEZ (“VELAZQUEZ”) arrived and delivered approximately 550 grams of a substance that later tested positive for cocaine to the CS on behalf on NEGRON, in exchange for the previously agreed sum of money.
