INFORMATION

The defendant having waived in open court prosecution by Indictment, the United States Attorney for the District of New Jersey charges:

Bankruptcy Fraud
(18 U.S.C. § 152(1))

1. At all times relevant to this Information, defendant BRYAN YOUNG ("YOUNG") was a resident of Toms River, in Ocean County, New Jersey, and owned and operated a landscaping business, Brys Landscaping, d/b/a AAA Interlocking Pavers, located in Lakewood, New Jersey.

2. On or about November 5, 2008, defendant YOUNG filed for individual Chapter 7 bankruptcy protection. That case was captioned In re: Bryan Young, Case No. 08-32333 (RTL) (Bankr. D.N.J.). In his bankruptcy petition (hereinafter the "Petition"), defendant YOUNG failed to report almost \$200,000 in personal assets.

3. Specifically, in the Petition, defendant YOUNG claimed to have \$100 in cash on hand, \$3,000 in a checking account, \$3,7000 in household goods and furnishings, \$450 in clothing, a 2006 Ford F-350 valued at \$8,000, and no other

personal property of any kind not already listed in Schedule B - Personal Property of the Petitioner. However, defendant YOUNG actually owned approximately \$174,865 in at least two financial accounts, approximately \$13,000 in household goods and furnishings, and an additional 2003 Ford truck valued at approximately \$10,000, at or around the time he filed the Petition.

4. On or about November 5, 2008, in the District of New Jersey, and elsewhere, the defendant,

BRYAN YOUNG,

knowingly and fraudulently concealed from a custodian, trustee, marshal, and other officer of the court charged with the control and custody of property, and, in connection with a case under Title 11, from creditors and the United States Trustee, property belonging to the estate of a debtor.

In violation of Title 18, United States Code, Sections 152(1) and 2.
