I, the undersigned complainant, being duly sworn, state that the following is true and correct to the best of my knowledge and belief. From on or about May 9, 2006, to on or about August 31, 2006, in Essex County, in the District of New Jersey and elsewhere, defendants ERIC CORBIN, a/k/a "Bang," FREDDIE DODDARD, a/k/a "Black," DAVID JONATHAS, a/k/a "Cash," DARRELL GRAY, a/k/a "Frog," UNDRA CROSBY, a/k/a "Boje," RASHEED WILLIAMS, a/k/a "Goldie Loc," QUADIR KING, a/k/a "Dollar," JAMES BLOCKER, a/k/a "Trig," ALONZO McMILLER, a/k/a "A.J.," and KAREEM CAMPBELL, a/k/a "K Rock," did:

knowingly and intentionally conspire and agree with each other and others to distribute and possess with intent to distribute more than 5 grams of a mixture or substance containing cocaine base, that is crack cocaine, a Schedule II narcotic drug controlled substance, contrary to Title 21, United States Code, Section 841(a) and (b)(1)(B)

in violation of Title 21, United States Code, Section 846.

I further state that I am a Task Force Officer with the Federal Bureau of Investigation, and that this complaint is based on the following facts:

Attachment A

I, Jason Walk, am a Task Force Officer with the Federal Bureau of Investigation. I have knowledge of the following facts based upon my investigation, review of reports and discussions with other law enforcement personnel and others. All statements herein are set forth in substance and in part:

1. Beginning in or about March 2006, an individual cooperating with law enforcement ("CW1") provided information that defendants ERIC CORBIN, a/k/a "Bang," FREDDIE DODDARD, a/k/a "Black," DAVID JONATHAS, a/k/a "Cash," DARRELL GRAY, a/k/a "Frog," UNDRA CROSBY, a/k/a "Boje," RASHEED WILLIAMS, a/k/a "Goldie Loc," QUADIR KING, a/k/a "Dollar," JAMES BLOCKER, a/k/a "Trig," ALONZO McMILLER, a/k/a "A.J.," and KAREEM CAMPBELL, a/k/a "K Rock," belonged to a criminal street gang known as the "Crips."

2. On or about May 9, 2006, in the Crescent Lane Housing Projects, in Irvington, New Jersey, another individual cooperating with law enforcement ("CW2"), purchased \$700 of "cook up" (which based on my training and experience is slang for cocaine base, or "crack" cocaine) from defendants DAVID JONATHAS and ERIC CORBIN, a/k/a "Bang." This transaction was observed by law enforcement and consensually video and audio-recorded. The "cook up" that CW2 purchased from defendants JONATHAS and CORBIN on May 9, 2006, was a white rock-like substance that field-tested positive for the presence of cocaine base and weighed approximately 35 grams (including packaging).

3. On or about July 12, 2006, in the Crescent Lane Housing Projects, in Irvington, New Jersey, another individual cooperating with law enforcement ("CW3"), purchased \$300 of "cook up" from defendants DARRELL GRAY, a/k/a "Frog," and KAREEM CAMPBELL, a/k/a "K Rock." This transaction was observed by law enforcement and consensually video and audio-recorded. The "cook up" that CW3 purchased from defendants GRAY and CAMPBELL on July 12, 2006, was a white rock-like substance that field-tested positive for the presence of cocaine base and weighed approximately 64 grams (including packaging).

4. On or about July 24, 2006, in the Crescent Lane Housing Projects, in Irvington, New Jersey, CW3 purchased \$300 of "cook up" from defendants DARRELL GRAY, a/k/a "Frog," and FREDDIE DODDARD a/k/a "Black." This transaction was observed by law enforcement and consensually video and audio-recorded. The "cook up" that CW3 purchased from defendants GRAY and DODDARD on July 24, 2006, was a white rock-like substance that field-tested positive for the presence of cocaine base and weighed approximately 7 grams (including packaging). Later that day, DODDARD told CW3 that he "supplied the Lane" (based on my training and experience, by this, DODDARD meant that he supplied

cocaine base to all of the dealers in the Crescent Lane Housing Projects).

5. On or about July 25, 2006, in the Crescent Lane Housing Projects, in Irvington, New Jersey, CW3 purchased \$300 of "cook up" from defendants ERIC CORBIN, a/k/a "Bang," and FREDDIE DODDARD, a/k/a "Black." This transaction was observed by law enforcement and consensually video and audio-recorded. The "cook up" that CW3 purchased from defendants CORBIN and DODDARD on July 25, 2006, was a white rock-like substance that field-tested positive for the presence of cocaine base and weighed approximately 21 grams (including packaging).

6. On or about August 16, 2006, in the Crescent Lane Housing Projects, in Irvington, New Jersey, CW1 purchased \$400 of "cook up" from defendant RASHEED WILLIAMS a/k/a "Goldie Loc." This transaction was observed by law enforcement and consensually video and audio-recorded. The "cook up" that CW1 purchased from defendant WILLIAMS on August 16, 2006, was a white rock-like substance that field-tested positive for the presence of cocaine base and weighed approximately 20 grams (including packaging).

7. On or about August 21, 2006, in the Crescent Lane Housing Projects, in Irvington, New Jersey, CW1 purchased \$100 of "cook up" from defendants QUADIR KING, a/k/a "Dollar," and UNDRAS CROSBY, a/k/a "Boje." This transaction was observed by law enforcement and consensually video and audio-recorded. The "cook up" that CW3 purchased from defendants KING and CROSBY on August 21, 2006, was a white rock-like substance that field-tested positive for the presence of cocaine base and weighed approximately 28 grams (including packaging).

8. On or about August 23, 2006, in the Crescent Lane Housing Projects, in Irvington, New Jersey, CW1 purchased \$1,250 of "cook up" from defendant JAMES BLOCKER, a/k/a "Trig," and an unidentified co-conspirator. This transaction was observed by law enforcement and consensually audio-recorded. The "cook up" that CW1 purchased from defendant BLOCKER on August 23, 2006, was a white rock-like substance that field-tested positive for the presence of cocaine base and weighed approximately 40 grams (including packaging).

9. On or about August 31, 2006, in the Crescent Lane Housing Projects, in Irvington, New Jersey, CW1 purchased \$500 of "cook up" from defendant ALONZO McMILLER, a/k/a "A.J." This transaction was observed by law enforcement and consensually audio-recorded. The "cook up" that CW1 purchased from defendant McMILLER on August 31, 2006, was a white rock-like substance that field-tested positive for the presence of cocaine base and weighed approximately 16 grams (including packaging).
