TO: UNITED STATES MARSHAL FOR THE DISTRICT OF NEW JERSEY OR OTHER
AUTHORIZED OFFICER

WHEREAS, on the _____ day of _____, 2006, a
Verified Complaint for Forfeiture was filed in the United States
District Court for the District of New Jersey by the United States
Attorney for said district, on behalf of the United States against
the above-captioned articles.

For the reasons and causes mentioned in said Verified
Complaint for Forfeiture; and said Complaint further praying for
the issuance of a warrant for arrest of said property to be had
and that all persons having an interest or right in the property
therein be cited to appear and show cause why the defendant
articles of food should not be condemned and forfeited to the
UNITED STATES;

NOW THEREFORE, warrant of arrest hereby issues, and all
persons having an interest or right therein shall be cited to
appear and answer all matters propounded in the Complaint and why
this Court should not order and decree the condemnation and
forfeiture of said articles of food.

YOU ARE THEREFORE COMMANDED: (1) to arrest, attach, and

retain the above-described articles of food in your custody or in the custody of a substitute custodian until further order of this Court respecting the same; (2) to affix a copy of this warrant to the defendant articles of food in a conspicuous place (if, in your discretion, you determine that the character or situation of the property is such that the taking of actual possession of the property is impracticable, you shall execute process by affixing a copy of this warrant to the defendant articles in a conspicuous place and by leaving a copy of the Complaint and process with the person having possession or his agent); (3) to give due notice to all persons asserting an interest or right in the property or having anything to say why the defendant property should not be condemned and disposed of pursuant to the prayer in the Complaint, that they must: (a) file with the Clerk or the United States District Court, District of New Jersey, a verified statement identifying the interest or right within thirty (30) days after the date of service of the government's Complaint, and (b) serve and file an answer within twenty (20) days after filing their verified statement of interest or right; (4) to give notice of this action and arrest to all persons by publication in a newspaper having general circulation in the city or county where the property has been seized, said notice to specify: (a) the Court, title, and number of the action; (b) the date of arrest, (c) the identity of the property arrested; (d) the name, address, and telephone number of the attorney for plaintiff; (e) that a verified statement of interest or right must be filed with the Clerk of the United States District Court, District of New Jersey, and served on the attorney for plaintiff within thirty (30) days after completed publication of notice as provided; (f) an answer

must be served and filed within twenty (20) days after filing the verified statement of interest or right; (g) that an application for intervention under Federal Rule 24 shall be filed within the time fixed by the Court; and (h) the name, address, and telephone number of the marshal; and (5) to promptly, after execution of this process, file same in this Court your return thereon.
