INDICTMENT

The Grand Jury charges:

Count 1

On or about February 12, 2010, in Bernalillo County, in the District of New Mexico, the defendants, **REYNA DOMINGUEZ-TRUJILLO and FROYLAN TORRES-HERNANDEZ**, did unlawfully, knowingly and intentionally combine, conspire, confederate, and agree with each other, and with other persons known and unknown to the Grand Jury, to commit the following offenses against the United States, to wit: possession with intent to distribute 500 grams and more of a mixture and substance containing a detectable amount of methamphetamine, contrary to 21 U.S.C. §§ 841(a)(1) and (b)(1)(A), and possession with intent to distribute less than 50 kilograms

of a mixture and substance containing a detectable amount of marijuana, contrary to 21 U.S.C. §§ 841(a)(1) and (b)(1)(D).

In violation of 21 U.S.C. § 846.

Count 2

On or about February 12, 2010, in Bernalillo County, in the District of New Mexico, the defendants, **REYNA DOMINGUEZ-TRUJILLO and FROYLAN TORRES-HERNANDEZ**, unlawfully, knowingly and intentionally possessed with intent to distribute 500 grams and more of a mixture and substance containing a detectable amount of methamphetamine.

In violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(A), and 18 U.S.C. § 2.

Count 3

On or about February 12, 2010, in Bernalillo County, in the District of New Mexico, the defendants, **REYNA DOMINGUEZ-TRUJILLO and FROYLAN TORRES-HERNANDEZ**, unlawfully, knowingly and intentionally possessed with intent to distribute less than 50 kilograms of a mixture and substance containing a detectable amount of marijuana.

In violation of 21 U.S.C. §§ 841(a)(1) and (b)(1)(D), and 18 U.S.C. § 2.
