THE GRAND JURY OF THE COUNTY OF RICHMOND, by this Indictment, accuses the defendant of the crime of:

CRIMINAL POSSESSION OF A CONTROLLED SUBSTANCE IN THE THIRD DEGREE (P.L. § 220.16-12), committed as follows:

The said defendant, in the Borough of Staten Island, County of Richmond, City and State of New York, on or about March 16, 2010, knowingly and unlawfully possessed a preparation, compound, mixture and substance of an aggregate weight of one-half ounce or more containing a narcotic drug, namely oxycodone.

AND THE GRAND JURY AFORESAID, by this Indictment, further accuses the said defendant of the crime of:

CRIMINAL POSSESSION OF A CONTROLLED SUBSTANCE IN THE SEVENTH DEGREE (P.L. § 220.03), committed as follows:

The said defendant, in the Borough of Staten Island, County of Richmond, City and State of New York, on or about March 16, 2010, knowingly and unlawfully possessed a controlled substance, namely, alprazolam.

C O U N T T H R E E

AND THE GRAND JURY AFORESAID, by this indictment, further accuses the said defendant of the crime of:

CRIMINAL POSSESSION OF A CONTROLLED SUBSTANCE IN THE FOURTH DEGREE (P.L. § 220.09-1), committed as follows:

The said defendant, in the Borough of Staten Island, County of Richmond, City and State of New York, on or about March 26, 2010, knowingly and unlawfully possessed one or more preparations, compounds, mixtures and substances of an aggregate weight of one-eighth ounce and more containing a narcotic drug, namely, oxycodone.

AND THE GRAND JURY AFORESAID, by this Indictment, further accuses the said defendant of the crime of:

FRAUD AND DECEIT (P.H.L. § 3397-4), committed as follows:

The said defendant, in the Borough of Staten Island, County of Richmond, City and State of New York, on or about March 1, 2010 and July 1, 2010, was supplied with a controlled substance and prescription therefore, to wit: oxycodone and alprazolam, by one practitioner, namely, Dr. Fredy Friedman, without the said defendant disclosing the fact that he was supplied during the same course of treatment with a controlled substance and a prescription therefor, to wit: oxycodone, by another practitioner.

C O U N T F I V E

AND THE GRAND JURY AFORESAID, by this Indictment, further accuses the said defendant of the crime of:

FRAUD AND DECEIT (P.H.L. § 3397-4), committed as follows:

The said defendant, in the Borough of Staten Island, County of Richmond, City and State of New York, on or about March 1, 2010 and July 1, 2010, was supplied with a controlled substance and prescription therefore, to wit: oxycodone, by one practitioner, namely, Dr. Alexandra Etkin, without the said defendant disclosing the fact that he was supplied during the same course of treatment with a controlled substance and a prescription therefor, to wit: oxycodone, by another practitioner.

FRAUD AND DECEIT (P.H.L. § 3397-4), committed as follows:

The said defendant, in the Borough of Staten Island, County of Richmond, City and State of New York, on or about March 1, 2010 and July 1, 2010, was supplied with a controlled substance and prescription therefore, to wit: oxycodone, by one practitioner, namely, Dr. Sharila Krishnan, without the said defendant disclosing the fact that he was supplied during the same course of treatment with a controlled substance and a prescription therefor, to wit: oxycodone, by another practitioner.
