3. The controlled substance involved in the offense was 280 grams and more of mixtures and substances containing a

detectable amount of cocaine base, in a form commonly known as crack, in violation of Title 21, United States Code, Section 841(b)(1)(A).

- c. On or about February 8, 2008, in the vicinity of 669 Arnow Avenue, Bronx, New York, TROY OWENS, the defendant, sold a quantity of crack cocaine to a UC in exchange for United States currency.

- f. On or about October 25, 2008, in the vicinity of 646 Allerton Avenue, Bronx, New York, MARQUIS BRANCH, a/k/a "Quist," the defendant, sold a quantity of crack cocaine to a UC in exchange for United States currency.
- g. On or about April 11, 2009, in the vicinity of 2821 Barker Avenue, Bronx, New York, ARMANI CUMMINGS, a/k/a "A1," the defendant, possessed a quantity of crack cocaine.
- h. On or about May 9, 2009, in the vicinity of 669 Adee Avenue, Bronx, New York, a co-conspirator not named as a defendant herein ("CC-1"), and YACKEEM McFARLANE, a/k/a "Captain," the defendant, sold a quantity of crack cocaine to a UC in exchange for United States currency.
- i. On or about August 19, 2009, in and around the vicinity of 2802 Olinville Avenue, Bronx, New York, (the "Carter Building") VICTOR ANDRADES, a/k/a "Spider," the defendant, sold crack cocaine to other individuals.
- j. On or about September 4, 2009, in the vicinity of 670 Adee Avenue, Bronx, New York ("670 Adee"), MILES instructed a UC to approach PONCE for crack cocaine. Thereafter, PONCE and CHARLES MATTHEWS, a/k/a "Chucky," the defendant, sold a

quantity of crack cocaine to the UC in exchange for United States currency.

- k. On or about September 11, 2009, in the vicinity of 640 Adee Avenue, Bronx, New York, ("640 Adee") BASIL JAMISON, the defendant, discharged a firearm.
- 1. On or about October 5, 2009, in the vicinity of Grand Concourse and East 169th Street, Bronx, New York, CUMMINGS and CHRISTOPHER NWANKO, a/k/a "Big Boi," a/k/a "CJ," the defendant, possessed a quantity of crack cocaine.

- q. On several occasions in 2010, in the vicinity of Barker Avenue and Britton Street, Bronx, New York, RODNEY

HINES, a/k/a "Bodyguard," the defendant, sold quantities of crack cocaine to other individuals.

- r. On various dates in 2010, in the vicinity of Olinville Avenue and Arnow Avenue, Bronx, New York, JOSE NICOLE, a/k/a "Bug Out," a/k/a "BO," the defendant, sold quantities of crack cocaine to other individuals.
- s. On or about February 12, 2010, in the vicinity of the Carter Building, LATASHA JOHNSON, a/k/a "La La," the defendant, possessed quantities of crack cocaine intended for resale to customers.
- t. On or about April 23, 2010, in the vicinity of 2823 Barker Avenue, Bronx, New York, THEODORE JOHNSON, a/k/a "Ole Boy," the defendant, possessed quantities of crack cocaine intended for resale to customers.
- u. On or about June 18, 2010, in the vicinity of 2825 Olinville Avenue, Bronx, New York, ("2825 Olinville") FELIPE ACEVEDO, a/k/a "Light," a/k/a "Macho," the defendant, sold a quantity of crack cocaine to a UC in exchange for United States currency.
- v. On or about July 16, 2010, inside 2825
  Olinville Avenue, Apartment 5D, Bronx, New York ("Apartment 5D"),
  KAREN BAXTON, the defendant, sold 5 ziplock bags of crack cocaine
  to a UC in exchange for \$60 in United States currency.
- w. On or about July 16, 2010, in the vicinity of 660 Arnow Avenue, Bronx, New York ("660 Arnow"), RICHARD

BARNWELL, a/k/a "Rob," the defendant, sold 2 ziplock bags of crack cocaine to a UC in exchange for United States currency.

x. On or about July 20, 2010, inside 2825 Olinville Avenue, Apartment 5B, Bronx, New York ("Apartment 5B"), VERLERIA THOMAS, a/k/a "Diamond," the defendant, sold 3 ziplock bags of crack cocaine to a UC in exchange for \$40 in United States currency.

y. On or about July 20, 2010, in the vicinity of 660 Arnow, JUSTIN FREYTES, a/k/a "Casper," the defendant, sold 2 ziplock bags of crack cocaine to a UC in exchange for \$20 in United States currency.

z. On or about July 28, 2010, in the vicinity of 660 Arnow, CAROLIN PEREZ, a/k/a "Carol," the defendant, acted as a look-out while BARNWELL sold 7 ziplock bags of crack cocaine to a UC in exchange for \$60 in United States currency.

aa. On or about July 28, 2010, inside Apartment 5B, JUANITA TUCKER, a/k/a "Trish," the defendant, sold 5 ziplock bags of crack cocaine to a UC in exchange for \$50 in United States currency.

bb. On or about July 30, 2010, in the vicinity of Apartment 5B, TWILER HOWARD, a/k/a "Cookie," the defendant, sold 1 ziplock bag of crack cocaine to a UC in exchange for \$20 in United States currency.

cc. On or about August 4, 2010, in the vicinity of the Carter Building, FREDERICK TOMLINSON, a/k/a "Bianca," the

gg. On or about September 2, 2010, in the vicinity of 660 Arnow, FAHEEM TAYLOR, a/k/a "Fii," the defendant, and BARNWELL sold 6 ziplock bags of crack cocaine to a UC in exchange for \$60 in United States currency.

hh. On or about September 28, 2010, in the vicinity of 660 Arnow, JOELL TOMLINSON, a/k/a "Geico," and CLYDE JONES, the defendants, sold 6 ziplock bags of crack cocaine to a UC in exchange for \$60 in United States currency.

look-out as a co-conspirator not named as a defendant herein ("CC-3"), sold 5 ziplock bags of crack cocaine to a UC in exchange for \$50 in United States currency.

On or about October 7, 2010, in the vicinity of 669 Arnow Avenue, Bronx, New York, JAMEL WRIGHT, a/k/a "Mel," a/k/a "Doo-Rag," the defendant, and a co-conspirator not named as a defendant herein ("CC-4"), sold 10 ziplock bags of crack cocaine to a UC in exchange for \$100 in United States currency.

kk. On or about October 13, 2010, in the vicinity of 660 Arnow, CC-4 and BENNY MONDAY, a/k/a "Sonic," the defendant, sold 7 ziplock bags of crack cocaine to a UC in exchange for \$60 in United States currency.

11. On or about October 19, 2010, in the vicinity of 2830 Olinville, JOSHUA PERRINGTON, a/k/a "Tattoo," the defendant, and BINNS discussed the sale of crack cocaine to another individual.

tt. On or about April 13, 2011, in the vicinity of 660 Arnow, GREGORY MILLS, a/k/a "G," the defendant, sold 9 ziplock bags of crack cocaine to a UC in exchange for \$80 in United States currency.

uu. On or about May 24, 2011 in the vicinity of the Carter Building, WAYNE LOWERY, a/k/a "BO," the defendant, sold a

quantity of crack cocaine to a UC in exchange for United States currency.

vv. On or about July 7, 2011, in the vicinity of 670 Adee, DIMITRI ALVARADO, the defendant, sold a quantity of crack cocaine to a UC in exchange for United States currency.

ww. On or about August 10, 2011, in the vicinity of 2825 Olinville, MICHAEL THOMPSON, a/k/a "Kenardo," and ANITA GARRET, a/k/a Shorty, the defendants, sold a quantity of crack cocaine to a UC in exchange for United States currency.

xx. On or about September 7, 2011, in the vicinity of 660 Arnow, JEFFREY PRESSLEY, a/k/a "Edward Pressley," a/k/a "Best," the defendant, sold a quantity of crack cocaine to a UC in exchange for United States currency.

yy. On or about September 20, 2011, in the vicinity of 2822 Bronx Park East NWANKO and SHAWN WEDDERBURN, a/k/a "Swell," the defendant, sold 7 ziplock bags of crack cocaine to a UC in exchange for \$70 in United States currency.

zz. On or about October 11, 2011, inside Apartment 5B, DONNELL HARRIS, the defendant, sold 6 ziplock bags of crack cocaine to a UC in exchange for \$60 in United States currency.

(Title 21, United States Code, Section 846.)

# COUNT TWO

5. From at least in or about October 2006, up to and including in or about December 2011, in the Southern District of New York and elsewhere, YACKEEM McFARLANE, a/k/a "Captain," CHRISTOPHER NWANKO, a/k/a "Big Boi," ARMANI CUMMINGS, a/k/a "Al,"

DASEAN RHODES, ALLEN COLON, a/k/a, "Poe," CHARLES MATTHEWS, a/k/a "Chucky," BERNARD MILES, a/k/a "Paul," CARLOS PONCE, a/k/a "Cali," ELVIN SKELTON, a/k/a "Butter," VICTOR ANDRADES, a/k/a "Spider," THEODORE JOHNSON, a/k/a "Ole Boy," and JOSE NICOLE, a/k/a "Bug Out," a/k/a "BO" the defendants, during and in relation to a drug trafficking crime for which they may be prosecuted in a court of the United States, namely, the narcotics offense charged in Count One of this Indictment, knowingly did use and carry firearms, and, in furtherance of such crimes, did possess firearms, and did aid and abet the use, carrying, and possession of firearms, which were brandished and discharged. (Title 18, United States Code, Sections 924(c)(1)(A)(iii) and 2.)

# FORFEITURE ALLEGATION

6. # Substitute Asset Provision

- 7. If any of the property described above as being subject to forfeiture, as a result of any act or omission of the defendants:
- a. cannot be located upon the exercise of due diligence;
- b. has been transferred or sold to, or deposited with, a third person;
- c. has been placed beyond the jurisdiction of the Court;
- d. has been substantially diminished in value; or
- e. has been commingled with other property which cannot be subdivided without difficulty;

it is the intention of the United States, pursuant to 21 U.S.C. § 853(p), to seek forfeiture of any other property of the said defendants up to the value of the above forfeitable property.
