**FOUR ARRESTED FOR BRONX DRUG TRAFFICKING**

LEV L. DASSIN, the Acting United States Attorney for the Southern District of New York, RAYMOND W. KELLY, the Police Commissioner of the City of New York, RONALD B. TURK, the Special Agent-in-Charge of the New York Field Division of the Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF"), and JOHN P. GILBRIDE, the Special Agent-In-Charge of the New York Field Division of the Drug Enforcement Administration ("DEA"), announced the arrests today of HARRISON BROWN, a/k/a "H," ALLAHVELL CUTTS, a/k/a "Vell", MALIK SAUNDERS, a/k/a "Man," and RASHEEM LEE, a/k/a "Godson," on charges of drug trafficking at various locations in the Bronx.

The arrests are the result of a two-year law enforcement operation led by the NYPD, ATF, and DEA, with the assistance of the New York State Division of Parole and the United States Marshals Service for the Southern District of New York.

BROWN, CUTTS, SAUNDERS and LEE are charged together with five additional individuals who have not been arrested -- HENRY FRANKLIN, a/k/a "BT," JOHN SUTTON, a/k/a "J-Black," RAHEAM

STEED, a/k/a "Heeni," CALEB HOOKER, a/k/a "Kahleaf," and WAJEEH BAKER -- in an Indictment unsealed today. Specific offenses charged and potential penalties are set forth below:

BROWN, CUTTS, SAUNDERS, and LEE are expected to be arraigned later today before a United States Magistrate Judge in Manhattan federal court.

Mr. DASSIN praised the investigative work of the NYPD, ATF, and DEA, and thanked the New York State Division of Parole and the United States Marshals Service for their invaluable assistance in this case.

Assistant United States Attorneys MARISSA MOLÉ, HOWARD MASTER, and JESSICA MASELLA are in charge of the prosecution.

The charges contained in the Indictment are merely accusations and the defendants are presumed innocent unless and until proven guilty.
