**FIFTEEN ARRESTED FOR DRUG TRAFFICKING CRIMES IN THE
AREA OF E. 184TH STREET AND TIEBOUT AVENUE**

LEV L. DASSIN, the Acting United States Attorney for the Southern District of New York, RAYMOND W. KELLY, the Police Commissioner of the City of New York, and JOHN P. GILBRIDE, the Special Agent-In-Charge of the New York Field Division of the Drug Enforcement Administration ("DEA"), announced today the arrests of fifteen individuals for drug trafficking crimes allegedly committed in the vicinity of East 184th Street and Tiebout Avenue; and 365 Ford Street, in the Bronx, New York, and within 1,000 feet of nearby schools, public housing projects, and playgrounds. Five charged defendants are in custody from previous separate charges and ten charged defendants remain at large.

The defendants are charged in three separate Indictments and face the following potential penalties, per count:

Defendants, TYQUAN MORRIS, ISAIAH PRESLEY, a/k/a "Freaky," JOEL RICHARDS, a/k/a "Jo Jo," DIANE CORDERO, a/k/a "Candy," KISHA MILLER, PHYLCIA S. EVANS, a/k/a "Pink," a/k/a "Tiny," STANLEY JACKSON, a/k/a "Turk," ANTHONY MANIGAULT, a/k/a "Ice," RALPH JACKSON, a/k/a "Bet," and MARK CAMPBELL, a/k/a "Red," remain at large. LAMAR THOMPSON, a/k/a "Pimp," a/k/a "P," ANTOINE EVANS, a/k/a "Ant," a/k/a "Freckles," SEVERNE WATSON, a/k/a "SP," JOHN SALABARRIA, a/k/a "Johnny," and ROBERT GONZALEZ, a/k/a "Poke," have already been in custody from separate state and federal charges.

Today's takedown is the culmination of a year-long law enforcement operation led by the New York City Police Department and DEA; with the assistance of the Bureau of Alcohol, Tobacco, Firearms and Explosives; and the United States Marshals Service for the Southern District of New York. The operation involved numerous purchases of crack cocaine made by undercover NYPD officers from drug dealers in the areas around Tiebout Avenue and Ford Street.

Mr. DASSIN praised the outstanding investigative work of each of those agencies.

Assistant United States Attorneys EDWARD Y. KIM and TELEMACHUS KASULIS are in charge of the prosecution.

The charges contained in the Indictments are merely accusations and the defendants are presumed innocent unless and until proven guilty.
