INDICTMENT

COUNT ONE

THE GRAND JURY CHARGES THAT:

On or about April 25, 2008, in Philadelphia, in the Eastern District of Pennsylvania, defendant

**MALKIEL SAR SHALOM AMOS,
a/k/a SAR AMOS**

knowingly received visual depictions which contained materials that had been shipped in interstate and foreign commerce, which visual depictions showed minors engaged in sexually explicit conduct and the producing of those visual depictions involved the use of minors engaged in sexually explicit conduct.

In violation of Title 18, United States Code, Section 2252(a)(2).

COUNT TWO

THE GRAND JURY FURTHER CHARGES THAT:

On or about April 25, 2008, in Philadelphia, in the Eastern District of Pennsylvania, defendant

**MALKIEL SAR SHALOM AMOS,
a/k/a SAR AMOS**

knowingly possessed books, magazines, periodicals, films, video tapes and other matter, namely one computer hard drive, which contained visual depictions that had been shipped and transported in interstate and foreign commerce, and were produced using materials that had been mailed, shipped, and transported in interstate and foreign commerce. The production of these visual depictions involved the use of minors engaging in sexually explicit conduct and the visual depictions were of minors engaging in sexually explicit conduct.

In violation of Title 18, United States Code, Section 2252(a)(4)(B).

NOTICE OF FORFEITURE

Upon conviction of the offenses alleged in Counts One and Two, the defendant,

**MALKIEL SAR SHALOM AMOS,
a/k/a SAR AMOS,**

shall forfeit to the United States, pursuant to Title 18, United States Code, Sections 2253(a)(1) and (a)(3), all visual depictions described in Title 18, United States Code Section 2252, and all property, real or personal, used or intended to be used to commit or promote the commission of the offenses of conviction, including but not limited to the following items that were seized from defendant on March 27, 2008:

- a. One HP Desktop computer, model Pavilion a450n, serial number MXK404011G, containing one Seagate Hard Drive model ST3160021A, serial number 3JS29PNS, 160.0 GB.
