## 26 INDICTED ON DRUG AND GUN CHARGES IN CONNECTION WITH CRACK DISTRIBUTION ORGANIZATION IN EASTON, PA

EASTON - United States Attorney Pat Meehan today announced the filing of several Indictments¹ charging conspiracy in a drug distribution organization. The superseding indictment alleges that Sean Rogers, a/k/a "S.P.", ran the operation, referred to as the S-P Crack Distribution Organization ("SPCO"), sold at least 15 kilograms of cocaine and crack cocaine to drug dealers, including members of the "Bloods" gang, in and around Easton, Pennsylvania. Rogers and his common-law wife, Anna Baez, are also charged with storing the drugs at their Easton home and with possession of a firearm in furtherance of a drug trafficking crime. Conservative estimates put the street value of the drugs that were distributed at more than a million dollars.

Charged in the drug conspiracy with Rogers and Baez are: Dawn Scott, Oliver Sims, a/k/a "Neefe", Karuan Goldsberry, a/k/a "K-Boogie", Mario Rivera, a/k/a "Bodie", Clarence Michael Curry, a/k/a "Angry Mike", John Jaudon, David Tuller, Jonathan White, a/k/a "Jay", Julian Joseph, a/k/a "Rude Boy", a/k/a "Rudy", Joseph Kelly, a/k/a "Kels", Clarence Pascal, a/k/a "Rel", Josh Oliver, Timothy Bowers, and Kendall Kinchen.

"When this type of drug activity infests neighborhoods, it chips away at the foundation of the community," said Meehan. "As the indictment alleges, this band of drug dealers was doing its part to spread a significant amount of drugs throughout Easton and make sure the foundation was damaged beyond repair."

According to the superseding indictment, from approximately June 2007 through Rogers and Baez took phone orders from and delivered crack cocaine to numerous regular customers who then repackaged the drugs for sale to their own customers in Easton, and elsewhere. The couple also possessed numerous firearms at their Easton home, allegedly to protect their drug activities and proceeds. On at least one occasion, defendant Rogers and defendant Dawn Scott sold crack cocaine to a customer within 1,000 feet of the Easton Catholic School. Rogers would get the

drugs from a supplier in New York City who is being charged in the Southern District of New York.

A separate indictment charges Holly Vandever and Kuwuan Rudolph, a/k/a "GC", with conspiracy to distribute 50 grams or more of cocaine base. According to the indictment, from October 2007 through December 2007, the defendants, both of Bethlehem, obtained crack cocaine from Sean Rogers several times a week and then re-sold the drugs in the Easton area. Vandever is also charged with possession with intent to distribute 5 grams or more of cocaine base. Rudolph is charged with possession with intent to distribute cocaine base and possession with intent to distribute 5 grams or more.

A separate indictment charges Ralick Cole, a/k/a "Buck", Dorian Rawlinson, a/k/a "Pee", and Kaseem Dobson, a/k/a "Strole", with conspiracy to distribute 50 grams or more of cocaine base. According to the indictment, from January 2007 to January 2008, the defendants purchased cocaine from Sean Rogers in Easton, PA, for the purpose of distributing and, on at least one occasion, Rogers delivered cocaine to the defendants at their Phillipsburg, NJ home. Cole is also charged with possession with intent to distribute 5 grams or more. Rawlinson is also charged with possession with intent to distribute. All three are also charged with use of a communications facility to facilitate the possession with intent to distribute.

A separate indictment charges Nicole Debra Sebro, a/k/a "Trinni", Rose Eileen Caban, a/k/a "Rose Berg", a/k/a "GG", and Jorge Omar Martinez Garcia, a/k/a "Omar", with conspiracy to distribute 50 grams or more of cocaine base. According to the indictment, from August 2006 to January 2008, the defendants purchased crack cocaine from Sean Rogers and re-sold the crack cocaine to customers in the Easton area. The defendants are also charged with possession with intent to distribute 5 grams or more.

A separate indictment charges Shamar Gray and Nancy Schanenberger, a/k/a "Shorty", with conspiracy to distribute 50 grams or more of cocaine base. According to the indictment, from August 2007 to January 2008, the defendants would place phone orders with Sean Rogers for crack cocaine and then re-sold the crack cocaine to customers in the Easton area. The defendants are also charged with possession with intent to distribute 5 grams or more.

This case is part of the "222 Corridor Anti-Gang Intitiative", a federally funded program designed to defeat some of the most violent and pervasive gangs in the country. The "222 Corridor" includes the cities of Allentown, Bethlehem, Easton, Reading, Lancaster, York, and Harrisburg. This initiative combines federal, state, and local law enforcement resources to attack gang crime and violence throughout the corridor.

If convicted of all charges, Rogers faces a mandatory minimum sentence of 25 years in prison with a maximum possible sentence of life; Baez, Scott, Sims, Curry, Pascal, Bowers, Kinchen, Vandever, Rudolph, Dobson, Caban, Garcia, Gray, and Schanenberger face mandatory minimum sentences of 10 years in prison with a maximum possible sentence of life; Cole faces a mandatory life sentence; Goldsberry, Rivera, Jaudon, Tuller, White, Joseph, Kelly, and Oliver face a mandatory minimum sentence of 5 years in prison with a maximum possible sentence of 40 years; Rawlinson, and Sebro face a mandatory minimum sentence of 20 years in prison with a maximum possible sentence of life.

This case was investigated by the Federal Bureau of Investigation, the Northampton County District Attorney's Office, the Warren County, NJ Prosecutor's Office, the Phillipsburg, NJ Police Department and is being prosecuted by Assistant United States Attorney John M. Gallagher.
