**INDICTMENT**

**THE GRAND JURY CHARGES THAT:**

On or about September 29, 2008, in Philadelphia, in the Eastern District of Pennsylvania, defendant

**MIGUEL ANGEL RIVERA**

knowingly possessed one or more computer hard drives, which contained visual depictions that had been shipped and transported in interstate and foreign commerce, and were produced using materials that had been mailed, shipped, and transported in interstate and foreign commerce. The production of these visual depictions involved the use of minors engaging in sexually explicit conduct and the visual depictions were of minors engaging in sexually explicit conduct.

In violation of Title 18, United States Code, Section 2252(a)(4)(B).

**NOTICE OF FORFEITURE**

**THE GRAND JURY FURTHER CHARGES THAT:**

1. As a result of the violation of Title 18, United States Code, Section 2252(a)(4)(B), set forth in this indictment, defendant

**MIGUEL ANGEL RIVERA**

shall forfeit to the United States of America:

- (a) any visual depiction which was produced, transported, mailed, shipped, or received in violation of Title 18, United States Code, Section 2252(a)(4)(B);
- (b) any property, real or personal, constituting or traceable to gross profits or other proceeds obtained from such offense;
- (c) any property, real or personal, used or intended to be used to commit or to promote the commission of such offense or any property traceable to such property, including, but not limited to:
  - 1. One Dell CPU serial number 7D2Y111.
  - 2. One Gateway CPU serial number 0014742299.
  - 3. One Gateway laptop with case, serial number N3263C1044363.
  - 4. One Apple laptop Powerbook G3, serial number CK8392FDEEY.
  - 5. One webcam, serial number unknown.
  - 6. One Pentax ZX7 35mm camera with film, serial number 3744133.
  - 7. One Arris Router serial number 79NBMV6A6274439.
  - 8. 53 DVDs/CDs, 5 VHS tapes, 2 Maxell Mini-DV tapes, (one with

broken tape) and one zip disk.

2. If any of the property subject to forfeiture, as a result of any act or omission of the defendant:

- (a) cannot be located upon the exercise of due diligence;
- (b) has been transferred or sold to, or deposited with, a third party;
- (c) has been placed beyond the jurisdiction of the Court;
- (d) has been substantially diminished in value; or
- (e) has been commingled with other property which cannot be divided without difficulty;

it is the intent of the United States, pursuant to Title 21, United States Code, Section 853(p), to seek forfeiture of any other property of the defendant up to the value of the property subject to forfeiture.

All pursuant to Title 18, United States Code, Section 2253.
