INDICTMENT

COUNT ONE

THE GRAND JURY CHARGES THAT:

On or about May 16, 2010, in the Eastern District of Pennsylvania, defendant

ALFREDO GASCA-CHAVEZ, a/k/a "Alfredo Navarro,"

an alien and a native and citizen of Mexico, who had previously been deported and removed from the United States on or about May 30, 2008, was found in the United States, having knowingly and unlawfully reentered the United States without first applying to the Attorney General of the United States or his successor, the Secretary for Homeland Security (Title 6, United States Code, Sections 202(3), (4) and 557), for permission to reapply for admission, and without receiving in response the express consent of the Attorney General or his successor to reapply for admission.

In violation of Title 8, United States Code, Sections 1326(a), (b)(2).

COUNT TWO

THE GRAND JURY FURTHER CHARGES THAT:

On or about May 16, 2010, in the Eastern District of Pennsylvania, defendant

ALFREDO GASCA-CHAVEZ, a/k/a "Alfredo Navarro,"

an alien and native and citizen of Mexico, while illegally and unlawfully in the United States, knowingly possessed in or affecting interstate commerce, a firearm, that is, a .45 caliber Smith and Wesson 1911SC handgun, serial number JRE6814, loaded with six live rounds of ammunition.

In violation of Title 18, United States Code, Section 922(g)(5)(A).

NOTICE OF FORFEITURE

THE GRAND JURY FURTHER CHARGES THAT:

As a result of the violation of Title 18, United States Code, Section 922(g)(5), set forth in this indictment, defendant

ALFREDO GASCA-CHAVEZ, a/k/a "Alfredo Navarro,"

shall forfeit to the United States of America the firearm and ammunition involved in the commission of such offense, including, but not limited to: a .45 caliber Smith and Wesson 1911SC handgun, serial number JRE6814, loaded with six live rounds of ammunition.

All pursuant to Title 28, United States Code, Section 2461(c), and Title 18, United States Code, Section 924(d).
