**INDICTMENT**

**COUNT ONE**

**THE GRAND JURY CHARGES THAT:**

On or about July 10, 2010 in Philadelphia, in the Eastern District of Pennsylvania, and elsewhere, defendant

**JUAN SANCHEZ,**  
**a/k/a "Papo,"**

having been convicted in a court of the Commonwealth of Pennsylvania of a crime punishable by imprisonment for a term exceeding one year, knowingly possessed in and affecting interstate commerce a firearm, that is, a Ruger, .22 caliber pistol, Model MK II, serial number 221-17934.

In violation of Title 18, United States Code, Sections 922(g)(1) and 924(e).

**COUNT TWO**

**THE GRAND JURY FURTHER CHARGES THAT:**

On or about August 26, 2010 in Philadelphia, in the Eastern District of Pennsylvania, and elsewhere, defendant

**JUAN SANCHEZ  
a/k/a "Papo"**

having been convicted in a court of the Commonwealth of Pennsylvania of a crime punishable by imprisonment for a term exceeding one year, knowingly possessed in and affecting interstate commerce four firearms, that is, a Raven Arms, .25 caliber pistol, Model MP-25, serial number 1739964, loaded with six live rounds of ammunition; a Spanish, .38 caliber revolver, Model M&P, serial number 10493, unknown make and model; a Ruger, 9 mm pistol, Model P95DC, with an obliterated serial number, loaded with ten live rounds of ammunition; and an Intratec, 9 mm handgun, Model AB-10, serial number AO38207.

In violation of Title 18, United States Code, Sections 922(g)(1) and 924(e).

**NOTICE OF FORFEITURE**

**THE GRAND JURY FURTHER CHARGES THAT:**

As a result of the violation of Title 18, United States Code, Section 922(g)(1), set forth in this indictment, defendant

**JUAN SANCHEZ,  
a/k/a "Papo,"**


shall forfeit to the United States of America the firearm and ammunition involved in the commission of this offense, including, but not limited to, a Raven Arms, .25 caliber pistol, Model MP-25, serial number 1739964, and six rounds of ammunition; a .38 caliber revolver, serial number 10493, unknown make and model; a Ruger, 9 mm pistol, Model P95DC, with an obliterated serial number, and ten rounds of ammunition; and an Intratec, 9 mm handgun, Model AB-10, serial number AO38207.

All pursuant to Title 28, United States Code, Section 2461(c), and Title 18, United States Code, Section 924(d).
