Merrell Hobbs: Mandatory minimum 10 year prison term up to life in prison.

Omar Roane: Mandatory minimum 10 year prison term up to life prison.

Terrance Hamm: Mandatory minimum 20 year prison term up to life in prison.

Reginald Stephens: Mandatory minimum 10 year prison term up to life in prison.

Damon Turner: Mandatory minimum 10 year prison term up to life in prison.

Bryan Hill: Mandatory minimum 10 year prison term up to life in prison.

Warren Stokes: Mandatory minimum 10 year prison term up to life in prison.

Allen Parker: Mandatory minimum 10 year prison term up to life in prison.

Khalil Allen: Mandatory minimum 20 year prison term up to life in prison.

Andre Tiller: Mandatory minimum 10 year prison term.

Tayale Shelton: Mandatory minimum 10 year prison term up to life in prison.

Hikeem Torrence: Mandatory minimum 10 year prison term up to life in prison.

Carol Miles: Mandatory minimum life prison term.

Shyheem Davis: Mandatory minimum 10 year prison term up to life in prison.

Melika Parker: Mandatory minimum 10 year prison term up to life in prison.

Roneisha Scott: Mandatory minimum 10 year prison term up to life in prison.
