**INDICTMENT**

**COUNT ONE**

**THE GRAND JURY CHARGES THAT:**

On or about October 6, 2009, in Levittown, in the Eastern District of Pennsylvania, and elsewhere, defendant

**DANIEL E. JONES,**  
    **a/k/a "rhymenoceros,"**  
    **a/k/a "limewithcoke,"**  
    **a/k/a "limewithcoke3,"**  
    **a/k/a "limewithcoke4,"**  
    **a/k/a "MinimusMaxim,"**

knowingly distributed, and attempted to distribute, visual depictions that had been shipped in interstate and foreign commerce, which visual depictions showed minors engaged in sexually explicit conduct and the producing of those visual depictions involved the use of minors engaged in sexually explicit conduct.

In violation of Title 18, United States Code, Section 2252(a)(2).

**COUNT TWO**

**THE UNITED STATES ATTORNEY FURTHER CHARGES THAT:**

From on or about October 6, 2009 to on or about November 17, 2009, in  
Levittown, in the Eastern District of Pennsylvania, and elsewhere, defendant

**DANIEL E. JONES,  
a/k/a "rhymenoceros,"  
a/k/a "limewithcoke,"  
a/k/a "limewithcoke3,"  
a/k/a "limewithcoke4,"  
a/k/a "MinimusMaxim,"**

knowingly possessed computer hard drives which contained more than 600 visual depictions that had been produced using materials that had been mailed, shipped, and transported in interstate and foreign commerce. The production of these visual depictions involved the use of minors engaging in sexually explicit conduct and the visual depictions were of minors engaging in sexually explicit conduct.

In violation of Title 18, United States Code, Section 2252(a)(4)(B).

**NOTICE OF FORFEITURE**

As a result of the violations of Title 18, United States Code, Sections 2252(a)(2) and (4), set forth in this indictment, defendant

shall forfeit to the United States of America any property used or intended to be used, in any manner or part, to commit, or to facilitate or promote the commission of, the violations of Title 18, United States Code, Sections 2252(a)(2) and (4), as charged in this indictment, including, but not limited to:


