### **COUNT ONE**

### THE GRAND JURY CHARGES THAT:

On or about December 21, 2009, in Philadelphia, in the Eastern District of Pennsylvania, defendant

knowingly and unlawfully, by force and violence, and by intimidation, took from employees of Sovereign Bank, located at 1500 Market Street, lawful currency of the United States, that is, approximately \$1,854, belonging to, and in the care, custody, control, management, and possession of Sovereign Bank, the deposits of which were insured by the Federal Deposit Insurance Corporation.

## **COUNT TWO**

## THE GRAND JURY FURTHER CHARGES THAT:

On or about December 23, 2009, in Philadelphia, in the Eastern District of Pennsylvania, defendant

#### MALCOLM DUNCAN

knowingly and unlawfully, by force and violence, and by intimidation, took from employees of Sovereign Bank, located at 1500 Market Street, lawful currency of the United States, that is, approximately \$2,297, belonging to, and in the care, custody, control, management, and possession of Sovereign Bank, the deposits of which were insured by the Federal Deposit Insurance Corporation.

### **COUNT THREE**

## THE GRAND JURY FURTHER CHARGES THAT:

On or about December 28, 2009, in Philadelphia, in the Eastern District of Pennsylvania, defendant

#### MALCOLM DUNCAN

knowingly and unlawfully, by force and violence, and by intimidation, took from employees of Beneficial Bank, located at 1600 Chestnut Street, lawful currency of the United States, that is, approximately \$1,564, belonging to, and in the care, custody, control, management, and possession of Beneficial Bank, the deposits of which were insured by the Federal Deposit Insurance Corporation.

### **COUNT FOUR**

## THE GRAND JURY FURTHER CHARGES THAT:

On or about December 31, 2009, in Philadelphia, in the Eastern District of Pennsylvania, defendant

#### MALCOLM DUNCAN

knowingly and unlawfully, by force and violence, and by intimidation, took from employees of Susquehanna Bank, located at 1635 Market Street, lawful currency of the United States, that is, approximately \$1,215, belonging to, and in the care, custody, control, management, and possession of Susquehanna Bank, the deposits of which were insured by the Federal Deposit Insurance Corporation.

### **COUNT FIVE**

# THE GRAND JURY FURTHER CHARGES THAT:

On or about January 7, 2010, in Philadelphia, in the Eastern District of Pennsylvania, defendant

#### MALCOLM DUNCAN

knowingly and unlawfully, by force and violence, and by intimidation, took from employees of Wachovia Bank, located at 101 N. Independence Mall East, lawful currency of the United States, that is, approximately \$2,520, belonging to, and in the care, custody, control, management, and possession of Wachovia Bank, the deposits of which were insured by the Federal Deposit Insurance Corporation.
