INDICTMENT

COUNT ONE

THE GRAND JURY CHARGES THAT:

On or about June 9, 2008, in Plymouth Meeting, in the Eastern District of Pennsylvania, defendant

ROBERT FRANZ,

knowingly received, and attempted to receive, a visual depiction, that is one image, that had been shipped and transported in interstate and foreign commerce, the producing of which visual depiction involved the use of a minor engaging in sexually explicit conduct, and such visual depiction was of a minor engaging in sexually explicit conduct.

In violation of Title 18, United States Code, Section 2252(a)(2) and (b)(1).

COUNT TWO

THE GRAND JURY FURTHER CHARGES THAT:

On or about August 3, 2009, in Plymouth Meeting, in the Eastern District of Pennsylvania, defendant

ROBERT FRANZ,

knowingly possessed one or more books, magazines, periodicals, films, video tapes and other matter, namely computer hard drives, magazines, and playing cards, which contained visual depictions that had been shipped and transported in interstate and foreign commerce, and were produced using materials that had been mailed, shipped, and transported in interstate and foreign commerce. The production of these visual depictions involved the use of minors engaging in sexually explicit conduct and the visual depictions were of minors engaging in sexually explicit conduct.

In violation of Title 18, United States Code, Section 2252(a)(4)(B).

NOTICE OF FORFEITURE

THE GRAND JURY FURTHER CHARGES THAT:

1. As a result of the violations Title 18, United States Code, Section 2252 set forth in this indictment, defendant

ROBERT FRANZ,

shall forfeit to the United States, all visual depictions described in Title 18, United States Code Section 2252, and all property, real or personal, used or intended to be used to commit or to facilitate the commission of the offenses of conviction, including but not limited to the following items that were seized from defendant on August 3, 2009:

- a. One Seagate USB External Hard Drive with Serial Number 5LS2X1A0.
- b. One Maxtor 7L250S0 Model Hard Drive with Serial Number L510DKYG.
- c. One magazine, "Child Love - Kinder Liebe 14" copyright 1973 in Denmark.
- d. One magazine, "Child Love - Kinder Liebe 17" copyright 1973 in Denmark.
- e. Playing cards - "Lollitots."

All pursuant to Title 18, United States Code, Section 2253.
