INDICTMENT

The Grand Jury charges that:

COUNT 1

Between on or about November 16, 2010 and December, 2011, in the District of Rhode Island and elsewhere, the defendant,

GLEN MATTESON,

did knowingly distribute a visual depiction that had been mailed and shipped and transported in interstate and foreign commerce, and which contained materials which had been so mailed and shipped and transported by any means, including by computer, the production of which involved the use of a minor engaging in sexually explicit conduct and which visual depiction was of such conduct.

All in violation of 18 U.S.C. §2252(a)(2).

COUNT 2

Between on or about November 21, 2010 and on or about February 21, 2012, the defendant,

GLEN MATTESON,

did knowingly receive a visual depiction that had been mailed and shipped and transported in interstate and foreign commerce, and which contained materials which had been so mailed and shipped and transported by any means, including by computer, the production of which involved the use of a minor engaging in sexually explicit conduct and which visual depiction was of such conduct.

All in violation of 18 U.S.C. §2252(a)(2).

COUNT 3

Between in or about March 2006 and February 21, 2012 in the District of Rhode Island and elsewhere, the defendant,

GLEN MATTESON,

did knowingly possess and access with intent to view one or more matters which contained a visual depiction of sexually explicit conduct, the production of which involved the use of a minor engaging in sexually explicit conduct, that had been transported in interstate and foreign commerce and which was produced using materials which had been transported in interstate and foreign commerce, by any means including by computer.

All in violation of Title 18, United States Code, Section 2252(a)(4).

FORFEITURE ALLEGATIONS

The Grand Jury further charges that:

As a result of the offenses alleged in Counts One, Two, and Three of this Indictment, pursuant to 18 U.S.C. § 2253 and 21 U.S.C. § 853 as specified at 18 U.S.C. § 2253(b), the Defendant, GLEN MATTESON, shall forfeit to the United States of America any and all property constituting visual depictions as described in 18 U.S.C. § 2253(a)(1); any property, real or personal, constituting or traceable to gross profits or other proceeds obtained from such offense as described in 18 U.S. C.§ 2253(a)(2); and any property, real or personal, used or intended to be used to commit or to promote the commission of such offense or any property traceable to such property as described in 18 U.S.C. § 2253(a)(3).
