TWENTY-FIRST DEFENDANT SENTENCED IN ST. CROIX TRIBAL DRUG INVESTIGATION

Madison, Wisconsin -- Stephen P. Sinnott, United States Attorney for the Western District of Wisconsin, announced that Broderick Swain, a/k/a "Whop," 34, Detroit, was sentenced yesterday to 54 months in prison without parole by U.S. District Judge Barbara B. Crabb. Swain previously pleaded guilty to conspiring with others to distribute crack cocaine on St. Croix tribal lands from approximately April 2006 to June 2008.

With yesterday's sentencing, twenty-one defendants have now been sentenced as a result of this investigation into drug dealing on St. Croix tribal lands. The previous defendants sentenced are set forth below:

United States Attorney Sinnott stated that yesterday's sentencing was the result of a long-term investigation being conducted by the Wisconsin Department of Justice, Division of Criminal Investigation; Federal Bureau of Investigation; St. Croix Tribal Police Department; Rice Lake Police Department; Barron County Sheriff's Department; Burnett County Sheriff's Department; Sawyer County Sheriff's Department; Polk County Sheriff's Department; Native American Drug & Gang Initiative; and the Wisconsin State Patrol.

As set out above, twenty-one defendants have now been convicted of federal drug

offenses as a result of this investigation. Louis and Brandon Belisle pleaded guilty on April 14 and will be sentenced on July 12. John Carr, Derrick Rapley, and Broderick Swain were charged in a nine-count indictment returned by the grand jury on December 2, 2009. Rapley has also pleaded guilty and will be sentenced by U.S. District Judge Barbara B. Crabb on May 24, 2010. Carr is set for a jury trial beginning on June 14, 2010.

Assistant U.S. Attorney John W. Vaudreuil is handling the prosecution of these cases.
