### **JUSTICE DEPARTMENT IS AWARDING ALMOST \$320 MILLION TO COMBAT OPIOID CRISIS**

#### ***Innovative Prosecution Solutions for Combating Violent Crime and Opioid Abuse (\$2.8 Million)***

Eight awards totaling more than \$2.8 million under the Bureau of Justice Assistance's (BJA) *Innovative Prosecution Solutions for Combating Violent Crime and Illegal Opioids* program will enable state, local and tribal prosecutors to develop programs to address violent crime and prosecute individuals responsible for homicides caused by illegal opioid use. The program encourages prosecutors to use data in the development of violent crime strategies and programs, building on analysis-driven, promising practices and evidence-based prosecution.

#### ***Comprehensive Opioid Abuse Site-based Program (\$162 Million)***

BJA is awarding 166 grants totaling more than \$162 million to jurisdictions in 45 states and one U.S. territory under BJA's *Comprehensive Opioid Abuse Site-based Program*, which provides financial and technical assistance to state, local and tribal jurisdictions to develop and implement efforts to identify, respond to, treat, and support those impacted by the opioid epidemic.

Authorized by the 2016 Comprehensive Addiction and Recovery Act, this program offers grant awards across six focus areas.

Category 1 awards support our nation's law enforcement officers and other first responders who are on the front lines of this epidemic responding to overdose calls day in and day out. Funding will support the development of partnerships in over 35 communities between first responders and treatment providers who will respond to overdoses as a team. In some instances, these teams will include a person trained to specifically address the needs of children who may be present at the scene of an overdose. These awards include:

Category 4 funding supports statewide planning and coordination between state level law enforcement, criminal justice, treatment and public health agencies with a focus on improving

the response to the opioid epidemic within the criminal justice system. States may elect to focus their planning and response efforts on prevention, enforcement, treatment or a combination of all three based on the needs of their state. These awards include:

Activities include improving prescriber enrollment and use of PDMPs, integrating PDMP data with other data sets to identify geographic areas of concern, doctor shopping, and problematic prescribing, supporting interstate data sharing of PDMP data, and improving the analytics available based on PDMP data. Finally, BJA announced it is awarding more than \$34 million under the *Comprehensive Opioid Abuse Program* to four training and technical assistance providers. This includes \$300,000 to expand peer recovery programs, approximately \$1.5 million to support the expansion of first responder diversion programs and provide technical assistance to criminal justice stakeholders including our Nation's sheriffs, judges, and prosecutors and additional funding to support priority areas. Over \$13 million of this funding will support demonstration projects that will be conducted in partnership with the U.S. Department of Health and Human Services (HHS). Demonstration sites will be selected through a competitive process later in the year.

### ***Justice and Mental Health Collaboration Program (\$5.9 Million)***

More than \$5.9 million via 15 awards will be awarded to jurisdictions under BJA's *Justice and Mental Health Collaboration Program (JMHC)*, which provides financial and technical assistance to facilitate collaborations among criminal justice, mental health, and substance abuse treatment systems. The purpose of these collaborations is to increase access to mental health and other treatment services for individuals with mental illness or co-occurring mental illness and substance abuse issues. While not all awards made under the JMHC program are focused explicitly on addressing the opioids epidemic, the following 15 awards were made in FY 2018 that focus specifically on opioid-related issues:

### ***Helping Children and Youth Impacted by Opioids (\$46.6 Million)***

OJP also announced it is awarding more than \$29.8 million to help youth impacted by the opioids crisis under OJP's Office for Victims of Crime's (OVC) *Enhancing Community Responses to the Opioid Crisis: Serving Our Youngest Crime Victims*. Of the more than \$29.8 million awarded, nearly \$2.5 million will be awarded to JBS International, Inc., to provide training and technical assistance to the grantees under the *Enhancing Community Responses to the Opioid Crisis: Serving Our Youngest Crime Victims* grant program.

Additionally, OJP's Office of Juvenile Justice and Delinquency Prevention (OJJDP) will be awarding more than \$7 million under the *Opioid Affected Youth Initiative*, including just over \$1 million to a training and technical assistance provider. ### ***Drug Courts (\$81.2 Million)***

More than \$81.2 million is being awarded to jurisdictions, academic institutions, and training and technical assistance providers to establish, expand, assist, and research the effectiveness of adult, family, and juvenile drug courts, including veteran’s treatment courts.

Drug courts have been demonstrated to reduce recidivism and substance abuse among high risk, high need participants and increase their likelihood of successful rehabilitation. These courts integrate evidence-based substance abuse treatment, mandatory drug testing, sanctions and incentives, and transitional services in judicially supervised court settings. OJP will fund several FY 2018 drug court programs, including BJA’s *Adult Drug Court Discretionary Grant Program* and *Veterans Treatment Court Program*, which provide financial and technical assistance to states, state courts, local courts, units of local government, and tribal governments to develop, implement, and enhance drug courts and Veterans Treatment Courts.

BJA is awarding more than \$47.4 million in three categories: implementation of new drug courts (Category 1); enhancement of fully operational drug courts that incorporate the evidence-based principles included in the National Association of Drug Court Professionals’ Adult Drug Courts Best Practice Standards (Category 2); and improvement, enhancement, or expansion of drug court services statewide (Category 3).

BJA also announced six additional awards of more than \$17.4 million to four organizations to provide training and technical assistance to the jurisdictions receiving funding under the FY 2018 *Adult Drug Court Discretionary Grant Program and the Veterans Treatment Court Program*. Included will be:

- **Planning support for new drug and Veterans Treatment Courts:** The National Association of Drug Court Professionals (\$4.85 million). This will include sub-awards to tribes to support planning and implementation of Veterans Treatment Courts and expanded treatment to bring the model to Tribal Healing to Wellness Courts.
- **Drug Court training for operational drug and Veterans Treatment Courts:** The National Association of Drug Court Professionals (\$4.38 million). This will include a new effort to build and expand training for Veterans Treatment Courts, with a particular emphasis on training to build a network of volunteer mentors.
- **Statewide drug court technical assistance:** The Center for Court Innovation (\$2.5 million). This includes efforts to support the expansion of Veterans Treatment Courts to rural communities in partnership with states, including up to \$600,000 in sub-awards.
- **Tribal Technical Assistance:** The Tribal Law and Policy Institute (\$1.75 million). This includes funds to coordinate efforts to better support and integrate veteran's resources into Tribal Healing to Wellness Court model.
- **Technical assistance to local implementation and enhancement courts:** The National Association of Drug Court Professionals (\$3,200,000).
- **National Drug Court Resource Center:** American University, Justice Programs Office (\$800,000).

OJJDP will award grants to 20 jurisdictions, totaling more than \$12.9 million, under its *Drug Treatments Courts Program*. This program seeks to build the capacity of state, local, and tribal drug court programs for juveniles in the justice system with substance abuse problems, specifically those related to opioid abuse, as well as those with co-occurring mental health disorders. Awards made under this program fall into one of three categories: service support delivery and programming enhancements aligned with OJJDP’s Juvenile Drug Treatment Court Guidelines (Category 1) and enhancement of existing Family Drug Court programs (Category 2) or implementation of new Family Drug Court programs (Category 3) that provide substance-abusing parents with support, treatment, and access to services.

OJJDP will award another \$1.5 million to the Center for Child and Family Futures to provide training and technical support. The Center is recognized as a national expert on developing, implementing, and sustaining collaborative approaches to child welfare- and court-involved families.

Generating new knowledge and tools improves our ability to enforce the law, ensure public safety, prevent and control crime, and ensure fair and impartial administration of justice. OJP’s National Institute of Justice (NIJ) plans to make the following opioid-related research awards.

Under the NIJ Research and Evaluation on Drugs and Crime program, the following \$1.35 million in awards will provide research that promotes effective law enforcement, court, and corrections responses to illegal drug markets. Awardees will conduct research on criminal investigation and prosecution and drug intelligence and community surveillance related to heroin and other opioids.

***Paul Coverdell Forensic Science Improvement Grant Program (\$17 Million)***

OJP plans to allocate up to \$17 million to support forensic activities related to opioids and synthetic drugs under the Paul Coverdell Forensic Science Improvement Grant Program. NIJ expects Coverdell grant funds to be used, in part, by medical examiners-coroners and forensic laboratories to address the dramatic increase in deaths and the backlogs of seized drugs as a result of the opioid crisis. Laboratories are overwhelmed with drug seizures and requests for toxicological analysis in opiate related crimes and deaths. Also, medical examiners and coroners are required to conduct unprecedented levels of autopsies and expend resources in opioid deaths.
