26 (1) The parties consent that a Final Judgment against

28 entered by the Court at any time after the expiration of thirty  
29 (30) days following the date of filing of this Stipulation with-  
30 out further notice to any party or other proceedings, either  
31 upon the motion of any party or upon the Court's own motion,  
32 provided that plaintiff has not withdrawn its consent as provided  
herein;


(2) That plaintiff may withdraw its consent hereto at  
any time within said period of thirty (30) days by serving  
notice thereof upon the other parties hereto and filing said  
notice with the Court.


1 (3) In the event plaintiff withdraws its consent


