ORDER

COLLEEN MCMAHON, Chief United States District Judge:

Plaintiff filed this action *pro se*. On February 10, 2017, the Court dismissed the complaint as frivolous. On February 28, 2017, Plaintiff filed a motion for summary judgment.

Plaintiff's motion, much like her original submission, is completely incomprehensible. Because Plaintiff's complaint has been dismissed as frivolous, Plaintiff's motion for summary judgment is therefore denied as moot.

CONCLUSION

Accordingly, Plaintiff's motion for summary judgment (ECF doc. #6) is denied as moot.

The Clerk of Court is directed to mail a copy of this order to Plaintiff and note service on the docket.

Plaintiff's case in this Court under Docket No. 16-CV-5933 (CM) is closed, though the Court will accept for filing documents that are directed to the Second Circuit Court of Appeals.¹ If Plaintiff files future submissions that are also meritless, the Court will direct that no further documents be accepted for filing for filing in this action, unless Plaintiff shows cause why such an order would be inappropriate.

¹ The Court notes that Plaintiff filed a notice of appeal on March 6, 2017.

The Court certifies under 28 U.S.C. § 1915(a)(3) that any appeal from this Order would not be taken in good faith, and therefore *in forma pauperis* status is denied for the purpose of an appeal. *See Coppedge v. United States*, 369 U.S. 438, 444-45 (1962).
