(1) The parties heretofore having by Stipulation filed
herein on July 17, 1970 consented to entry of a proposed Final
Judgment in the form attached to said Stipulation, and the
parties now desiring to make certain changes in that proposed
Final Judgment, as described below, the parties consent to the
filing and entry by the Court on or at any time after August 17,
1970 without further notice to either party or upon the Court's
own motion of the attached proposed Final Judgment;

(2) The only differences between the Final Judgment in the
form attached hereto and the proposed Final Judgment filed
herein July 17, 1970 are the following:

(a) Addition of defendant Geigy International A.G.,
(i) to the caption, (ii) to Section I and (iii) to sub-
section (F) of Section II;

(b) Addition of the phrase "including the rele-
vant machinery and equipment located in these premises,"
following the phrase "Branch offices and facilities,"
in paragraph (4) of Appendix A;

(c) Elimination of Patent No. 3,238,351
with respect to Metobromuron in Appendix D
and substitution of Patent No. 3,288,851;

(d) Addition of Patent Application No.
4826-E-CIP/10/DIV with respect to Chlorbro-
muron in Appendix D.
