STIPULATION

It is hereby stipulated by and among the undersigned parties, acting by their respective attorneys, that:

1. Upon such notice and hearing as the Court may order pursuant to the provisions of Rule 23(e), and subject to the terms hereafter recited, the parties agree that a Final Judgment, in the form attached hereto, as Exhibit "A," may be entered by the Court;

2. Such Final Judgment may be entered by the Court at any time after the expiration of thirty (30) days following the date of the hearing on the entry of Final Judgment without further notice to any party or other proceedings, either upon the motion of any party or upon the Court's own motion, provided that plaintiff has not withdrawn its consent as provided herein;

3. The plaintiff may withdraw its consent hereto at any time within said period of thirty (30) days by serving notice thereof upon all other parties hereto and filing said notice with the Court;

4. In the event plaintiff withdraws its consent hereto, neither this proceeding nor the making of this Stipulation nor the filing of the attached Proposed Final Judgment shall in any manner prejudice any consenting party in any subsequent proceedings.


5. There are attached hereto the following:

(a) An affidavit of Vincent P. Comerford, Senior V.P. in Charge of Marketing of Arnold Bakers, Inc., identifying in exhibits attached thereto, the names and addresses of the persons constituting the class of wholesalers and of the persons constituting the class of sub-distributors in each case as of approximately October 1, 1969.

(b) An affidavit of counsel for the defendant wholesalers concerning (i) the mailing of notice of the proposed disposition of this case on the basis of the Final Judgment, Exhibit "A," (ii) the approvals received by him from persons comprising the class of wholesalers, and (iii) approvals of persons constituting the class of wholesalers obtained by Arnold Bakers, Inc.

(c) An affidavit of counsel for the defendant sub-distributors concerning (i) the mailing of notice of the proposed disposition of this case on the basis of the Final Judgment, Exhibit "A," (ii) approvals received by him from persons comprising the class of sub-distributors, and (iii) approvals of persons constituting the class of sub-distributors obtained by Arnold Bakers, Inc.


