STIPULATION

It is stipulated by and between the undersigned parties, by their respective attorneys, that:

(1) Plaintiff, United States of America, and defendants Asiatic Petroleum Corporation and C. H. Sprague & Son Company, consent that a Final Judgment in the form hereto attached may be filed and entered by the Court at any time after the expiration of thirty (30) days following the date of filing of this Stipulation without further notice to any party or other proceedings, either upon the motion of any party or upon the Court's own motion, provided that plaintiff has not withdrawn its consent as provided herein;

(2) Pursuant to Rule 41(a)(1)(ii) of the Federal Rules of Civil Procedure, this action shall be dismissed without prejudice as to defendant Sprague Associates, Inc., upon entry by the Court of the Final Judgment referred to in paragraph (1) of this Stipulation;

(3) The plaintiff may withdraw its consent hereto at any time within said period of thirty (30) days by serving notice thereof upon the other parties hereto and filing said notice with the Court;

(4) In the event plaintiff withdraws its consent hereto, this Stipulation shall be of no effect whatever in this or any other proceeding and the making of this Stipulation shall not in any manner prejudice any consenting party in any subsequent proceedings.





