STIPULATION

It is stipulated by and between the undersigned parties,  
by their respective attorneys, that:

- (1) The plaintiff, United States of America, and defendant, General Adjustment Bureau, Inc., consent that a Final Judgment in the form hereto attached may be filed and entered by the Court at any time after the expiration of thirty (30) days following the date of filing of this stipulation without further notice to any party or upon the Court's own motion, provided that plaintiff has not withdrawn its consent as provided herein;
- (2) Each of the undersigned companies, being the shareholders listed in Exhibit I of the above mentioned Final Judgment, hereby waive service of the complaint filed herein and consent to be bound by the provisions of Sections V and XV of the attached Final Judgment;
- (3) The plaintiff may withdraw its consent hereto at any time within said period of thirty (30) days by serving

notice thereof upon the other party hereto and filing said notice with the Court;

(4) In the event plaintiff withdraws its consent hereto, this stipulation shall be of no effect whatever in this or any other proceeding and the making of this stipulation shall not in any manner prejudice any consenting parties in any subsequent proceedings.
