[PROPOSED] FINAL JUDGMENT

WHEREAS, the United States of America filed its Complaint on November 16, 2012, alleging that the Defendant participated in an agreement in violation of Section One of the Sherman Act, and the United States and the Defendant, by their attorneys, have consented to the entry of this Final Judgment without trial or further adjudication of any issue of fact or law;

AND WHEREAS, this Final Judgment does not constitute any admission by the Defendant that the law has been violated or of any issue of fact or law;

AND WHEREAS, the Defendant agrees to be bound by the provisions of this Final Judgment pending its approval by this Court;

NOW THEREFORE, before any testimony is taken, without trial or further adjudication of any issue of fact or law, and upon consent of the Defendant, it is ORDERED, ADJUDGED, AND DECREED:

I. JURISDICTION

This Court has jurisdiction over the subject matter and the parties to this action. The Complaint states a claim upon which relief may be granted against the Defendant under Section One of the Sherman Act, as amended, 15 U.S.C. § 1.

1 **II. DEFINITIONS**

2 As used in this Final Judgment:

3 A. **“eBay”** means eBay Inc., its (i) successors and assigns, (ii) controlled subsidiaries,
4 divisions, groups, affiliates, partnerships, and joint ventures, and (iii) directors, officers,
5 managers, agents acting within the scope of their agency, and employees.

6 B. **“Agreement”** means any contract, arrangement, or understanding, formal or
7 informal, oral or written, between two or more persons.

8 C. **“No direct solicitation provision”** means any agreement, or part of an agreement,
9 among two or more persons that restrains any person from cold calling, soliciting, recruiting,
10 hiring, or otherwise competing for employees of another person.

11 D. **“Person”** means any natural person, corporation, company, partnership, joint
12 venture, firm, association, proprietorship, agency, board, authority, commission, office, or other
13 business or legal entity, whether private or governmental.

14 E. **“Senior manager”** means any company officer or employee above the level of
15 vice president.

16 **III. APPLICABILITY**

17 This Final Judgment applies to eBay, as defined in Section II, and to all other persons in
18 active concert or participation with eBay who receive actual notice of this Final Judgment by
19 personal service or otherwise.

20 **IV. PROHIBITED CONDUCT**

21 The Defendant is enjoined from attempting to enter into, entering into, maintaining or
22 enforcing any agreement with any other person to in any way refrain from, requesting that any
23 person in any way refrain from, or pressuring any person in any way to refrain from hiring,
24 soliciting, cold calling, recruiting, or otherwise competing for employees of the other person.

V. CONDUCT NOT PROHIBITED

A. Nothing in Section IV shall prohibit the Defendant and any other person from attempting to enter into, entering into, maintaining or enforcing a no direct solicitation provision, provided the no direct solicitation provision is:

1. contained within existing and future employment or severance agreements with the Defendant's employees;
2. reasonably necessary for mergers or acquisitions, consummated or unconsummated, investments, or divestitures, including due diligence related thereto;
3. reasonably necessary for contracts with consultants or recipients of consulting services, auditors, outsourcing vendors, recruiting agencies or providers of temporary employees or contract workers;
4. reasonably necessary for the settlement or compromise of legal disputes; or
5. reasonably necessary for (i) contracts with resellers or OEMs; (ii) contracts with providers or recipients of services other than those enumerated in paragraphs V.A.1 - 4 above; or (iii) the function of a legitimate collaboration agreement, such as joint development, technology integration, joint ventures, joint projects (including teaming agreements), and the shared use of facilities.

B. All no direct solicitation provisions that relate to written agreements described in Section V.A.5.i, ii, or iii that the Defendant enters into, renews, or affirmatively extends after the date of entry of this Final Judgment shall:

1. identify, with specificity, the agreement to which it is ancillary;
2. be narrowly tailored to affect only employees who are anticipated to be directly involved in the agreement;

- 1 3. identify with reasonable specificity the employees who are subject to the
- 2 agreement;
- 3 4. contain a specific termination date or event; and
- 4 5. be signed by all parties to the agreement, including any modifications to
- 5 the agreement.

6 C. For all no direct solicitation provisions that relate to unwritten agreements
7 described in Section V.A.5.i, ii, or iii, that the Defendant enters into, renews, or affirmatively
8 extends after the date of entry of this Final Judgment, the Defendant shall maintain documents
9 sufficient to show:

- 10 1. the specific agreement to which the no direct solicitation provision is
- 11 ancillary;
- 12 2. the employees, identified with reasonable specificity, who are subject to
- 13 the no direct solicitation provision; and
- 14 3. the provision's specific termination date or event.

15 D. The Defendant shall not be required to modify or conform, but shall not enforce,
16 any no direct solicitation provision to the extent it violates this Final Judgment if the no direct
17 solicitation provision appears in the Defendant's consulting or services agreements in effect as of
18 the date of this Final Judgment (or in effect as of the time the Defendant acquires a company that
19 is a party to such an agreement).

20 E. Nothing in Section IV shall prohibit the Defendant from unilaterally deciding to
21 adopt a policy not to consider applications from employees of another person, or to solicit, cold
22 call, recruit or hire employees of another person, provided that the Defendant is prohibited from
23 requesting that any other person adopt, enforce, or maintain such a policy, and is prohibited from
24 pressuring any other person to adopt, enforce, or maintain such a policy.

25 **VI. REQUIRED CONDUCT**

26 A. The Defendant shall:

- 1 1. furnish a copy of this Final Judgment and related Competitive Impact
2 Statement within sixty (60) days of entry of the Final Judgment to its
3 officers, directors, human resources managers, and senior managers who
4 supervise employee recruiting, solicitation, or hiring efforts;
- 5 2. furnish a copy of this Final Judgment and related Competitive Impact
6 Statement to any person who succeeds to a position described in Section
7 VI.A.1 within thirty (30) days of that succession;
- 8 3. annually brief each person designated in Sections VI.A.1 and VI.A.2 on
9 the meaning and requirements of this Final Judgment and the antitrust
10 laws;
- 11 4. obtain from each person designated in Sections VI.A.1 and VI.A.2, within
12 sixty (60) days of that person's receipt of the Final Judgment, a
13 certification that he or she (i) has read and, to the best of his or her ability,
14 understands and agrees to abide by the terms of this Final Judgment; (ii) is
15 not aware of any violation of the Final Judgment that has not been
16 reported to the Defendant; and (iii) understands that any person's failure to
17 comply with this Final Judgment may result in an enforcement action for
18 civil or criminal contempt of court against the Defendant and/or any
19 person who violates this Final Judgment;
- 20 5. provide employees reasonably accessible notice of the existence of all
21 agreements covered by Section V.A.5 and entered into by the company;
22 and
- 23 6. maintain (i) a copy of all agreements covered by Section V.A.5; and (ii) a
24 record of certifications received pursuant to this Section.

25 B. For five (5) years after the entry of this Final Judgment, on or before its
26 anniversary date, the Defendant shall file with the United States an annual statement identifying
27

1 and providing copies of any agreement and any modifications thereto described in Section
2 V.A.5, as well as describing any violation or potential violation of this Final Judgment known to
3 any officer, director, human resources manager, or senior manager who supervises employee
4 recruiting, solicitation, or hiring efforts. Descriptions of violations or potential violations of this
5 Final Judgment shall include, to the extent practicable, a description of any communications
6 constituting the violation or potential violation, including the date and place of the
7 communication, the persons involved, and the subject matter of the communication.

8 C. If any officer, director, human resources manager, or senior manager who
9 supervises employee recruiting, solicitation, or hiring efforts of the Defendant learns of any
10 violation or potential violation of any of the terms and conditions contained in this Final
11 Judgment, the Defendant shall promptly take appropriate action to terminate or modify the
12 activity so as to comply with this Final Judgment and maintain all documents related to any
13 violation or potential violation of this Final Judgment.

14 VII. COMPLIANCE INSPECTION

15 A. For the purposes of determining or securing compliance with this Final Judgment,
16 or of determining whether the Final Judgment should be modified or vacated, from time to time
17 authorized representatives of the United States Department of Justice, including consultants and
18 other persons retained by the United States, shall, upon the written request of an authorized
19 representative of the Assistant Attorney General in charge of the Antitrust Division, and on
20 reasonable notice to the Defendant, subject to any legally recognized privilege, be permitted:

- 21 1. access during the Defendant's regular office hours to inspect and copy, or
22 at the option of the United States, to require the Defendant to provide
23 electronic or hard copies of, all books, ledgers, accounts, records, data,
24 and documents in the possession, custody, or control of the Defendant,
25 relating to any matters contained in this Final Judgment; and
26

1 2. to interview, either informally or on the record, the Defendant’s officers,
2 employees, or agents, who may have their counsel, including any
3 individual counsel, present, regarding such matters. The interviews shall
4 be subject to the reasonable convenience of the interviewee and without
5 restraint or interference by the Defendant.

6 B. Upon the written request of an authorized representative of the Assistant Attorney
7 General in charge of the Antitrust Division, the Defendant shall submit written reports or
8 responses to written interrogatories, under oath if requested, relating to any of the matters
9 contained in this Final Judgment as may be requested.

10 C. No information or documents obtained by the means provided in this section shall
11 be divulged by the United States to any person other than an authorized representative of the
12 executive branch of the United States, except in the course of legal proceedings to which the
13 United States is a party (including grand jury proceedings), or for the purpose of securing
14 compliance with this Final Judgment, or as otherwise required by law.

15 D. If at the time information or documents are furnished by the Defendant to the
16 United States, the Defendant represents and identifies in writing the material in any such
17 information or documents to which a claim of protection may be asserted under Rule 26(c)(1)(G)
18 of the Federal Rules of Civil Procedure, and the Defendant marks each pertinent page of such
19 material, “Subject to claim of protection under Rule 26(c)(1)(G) of the Federal Rules of Civil
20 Procedure,” then the United States shall give the Defendant ten (10) calendar days notice prior to
21 divulging such material in any legal proceeding (other than a grand jury proceeding).

22 **VIII. RETENTION OF JURISDICTION**

23 This Court retains jurisdiction to enable any party to this Final Judgment to apply to this
24 Court at any time for further orders and directions as may be necessary or appropriate to carry
25 out or construe this Final Judgment, to modify any of its provisions, to enforce compliance, and
26 to punish violations of its provisions.

IX. EXPIRATION OF FINAL JUDGMENT

Unless this court grants an extension, this Final Judgment shall expire five (5) years from the date of its approval by the Court.

XI. PUBLIC INTEREST DETERMINATION

Based upon the record before the Court, which includes the Competitive Impact Statement and any comments and response to comments filed with the Court, entry of this final judgment is in the public interest.
