12 It is stipulated by and between the undersigned
13 parties, by their respective attorneys, that:

14 1. The Court has jurisdiction over the subject matter
15 of this action and over each of the parties hereto, and
16 venue of this action is proper in the District of Arizona;

17 2. The parties consent that a Final Judgment in the
18 form hereto attached may be filed and entered by the Court,
19 upon the motion of any party or upon the Court's own motion,
20 at any time after compliance with the requirements of the
21 Antitrust Procedures and Penalties Act (15 U.S.C. 16), and
22 without further notice to any party or other proceedings,
23 provided that Plaintiff has not withdrawn its consent, which
24 it may do at any time before the entry of the proposed Final
25 Judgment by serving notice thereof on Defendants and by
26 filing that notice with the Court; and

1 3. Defendants agree to be bound by the provisions of
2 the proposed Final Judgment pending its approval by the
3 Court. If the Plaintiff withdraws its consent or if the
4 proposed Final Judgment is not entered pursuant to this
5 Stipulation, this Stipulation shall be of no effect
6 whatsoever, and the making of this Stipulation shall be
7 without prejudice to any party in this or in any other
8 proceeding.




