UNITED STATES' SECOND REPORT ON EXTENSIONS OF TIME FOR DIVESTITURES

Plaintiff, United States of America, hereby informs the Court of certain extensions of time that it has agreed to grant to the Defendants in this matter to complete the divestitures of Parking Facilities required by the Final Judgment. No action on the part of the Court is necessary at this time.

The Court entered and filed the Final Judgment as of January 3, 2013, and notice of entry to Plaintiff and Defendants was given on the same date. Under Paragraph IV.A of the Final Judgment, Defendants were then required to divest all their interests in the Parking Facilities listed in Schedule A within five days after notice of entry of the Final Judgment, that is, by January 8, 2013.

Paragraph IV.D of the Final Judgment permits the United States, in its sole discretion, to agree to one or more extensions of the time period for divestiture, not to exceed ninety calendar

days in total. The same provision also requires the United States to inform the Court of any such extensions granted.

As explained in the United States' Report on Extensions of Time for Divestitures filed on January 11, 2013, Defendants advised the United States that 50 of the 107 divestitures of Parking Facilities required by the Final Judgment were completed prior to the January 8, 2013 deadline. On January 8, the United States agreed to limited extensions of time for the 57 remaining Parking Facilities that had not been divested, allowing until February 7, 2013 for 39 of the divestitures, until March 9, 2013 for 17 of the divestitures, and until April 8, 2013 for one of the divestitures.

Defendants recently advised the United States that an additional 25 divestitures have been completed prior to February 7, 2013. Of these facilities, 21 were in the group that had been scheduled to be divested by February 7, while four were in the group that had been scheduled to be divested by March 9.

On February 7, 2013, the United States agreed to limited extensions of time for completion of the remaining 18 divestitures of Parking Facilities in the first group that had originally been scheduled for divestiture on February 7, providing an additional 30 days for completion of these divestitures, until March 9. These additional extensions were based on the representations of Defendants that additional time would be needed to complete those divestitures and Defendants' explanations of the need for additional time.

In granting these extensions, the United States has considered the substantial progress that Defendants have already made, with nearly three-quarters of the required divestitures completed. The United States has also taken into account Defendants' representations that they

anticipate they can complete the 18 divestitures for which the additional time has been granted by the end of February 2013. Almost all of the other divestitures for which no additional extension is needed are also scheduled to be completed by the end of February 2013, so that it appears that few divestitures will remain to be completed in March 2013.

Defendants have represented that the additional time needed to divest these 18 facilities is attributable to several factors. Eight of these facilities are expected to be divested through terminations of the agreements with the owners pursuant to Paragraph IV.K of the Final Judgment. For all of the facilities where Standard is terminating agreements, the owners need to select new operators. For three of these facilities, the 60 day notice period to the owners required by the Final Judgment has not yet been completed. Defendants have represented that they have continued to operate these eight facilities even where the 60 day notice period has been completed pending the selection of new operators.¹ The remaining ten facilities for which an extension is needed are expected to be divested through assignments of Standard's rights to new parking operators, a process that also often requires approval of the facility owners. For these ten facilities, Standard has had to negotiate the assignments and select a new operator that will be acceptable both to the owner of the facility and to the United States. The United States understands that Standard has reached agreements in principle for assignment of all ten of these facilities, but most of them have not yet been submitted for the approval of the United States as consent of the owners is still being obtained.

¹ Defendants have noted that the Asset Preservation Stipulation and Order entered by this Court on October 1, 2012 obliges them to continue to ensure that the Parking Facilities remain economically viable, competitive and ongoing providers of off-street parking services pending divestiture.

The time extensions to complete the divestitures of individual Parking Facilities agreed to by the United States are as follows:

1. For the following 18 Parking Facilities not yet divested, the United States has now agreed to extensions of the time for divestiture for an additional 30 days, so that, together with the 30 days initially granted, divestiture is now required by March 9, 2013: Bronx C4, Chicago C14 and S13, Cleveland C1, C4 and C5, Columbus C5 and C8, Denver C13, S19, S29, and S33, Fort Worth C4, C22, and C23, Los Angeles C22, New Orleans C2, and Philadelphia C18. Of these 18 Parking Facilities, the United States has already recently approved the agreement for the divestiture of Cleveland C5, and has under review agreements for the divestiture of Columbus C8 and Philadelphia C18, which Defendants notified for consideration early in February 2013.

2. For the following 13 Parking Facilities not yet divested, the United States has previously agreed to extensions of the time for divestiture for a total of 60 days, that is, until March 9, 2013: Charlotte C5 and C17, Columbus C2, Houston C17 (which had been the subject of a substitution request that the United States rejected on December 20, 2012), Miami C22, Minneapolis C7, New Orleans C8 and C10, Philadelphia S9 (substituted for Philadelphia C13 in the original Schedule A with the approval of the United States on December 20, 2012), Rego Park S4 and S5, and Tampa C13 and C14;

3. For the following Parking Facility, the United States has agreed to extensions of the time for divestiture for a total of 90 days, that is, until April 8, 2013: Denver C14.

For the convenience of the Court, the United States has also included with this report a modified version of Schedule A to the Final Judgment. The modified Schedule A shows the divestiture status and extensions of time for divestiture now applicable to each of the Parking Facilities. It also shows the three substitutions of other Parking Facilities for ones originally listed in Schedule A that the United States has approved, and about which it informed the Court in its Certificate of Compliance and Report on Facilities Substitution filed on December 21, 2012.
