- (3) in the event Plaintiff withdraws its consent or if the proposed Final Judgment is not entered pursuant to this Stipulation, this Stipulation shall be of no effect whatsoever and the

making of this Stipulation shall be without prejudice to any party in this or any other proceeding;

Section 7A(g)(1) of the Clayton Act, 15 U.S.C. § 18a(g)(1), against Defendant for failure to

comply with Section 7A of the Clayton Act, 15 U.S.C. § 18a, in connection with Defendant's

acquisition of voting securities of TangoMe, Inc. in 2014, and Defendant's acquisition of voting

securities of LyondellBasell Industries N.V. in 2010.
