17 STIPULATION

18 It is stipulated by and between the undersigned parties,
19 plaintiff United States of America and defendants KDI
20 Corporation and KDI-Aqua Systems, Inc., by their respective
21 attorneys, that:

22 (1) The parties consent that a Final Judgment against
23 said defendants in the form hereto attached may be filed and
24 entered by the Court at any time after the expiration of
25 thirty (30) days following the date of filing of this
26 Stipulation without further notice to any party or other
27 proceedings, either upon the motion of any party or upon the
28 Court's own motion, provided that plaintiff has not withdrawn
29 its consent as provided herein;

30 (2) The plaintiff may withdraw its consent hereto at
31 any time within said period of thirty (30) days by serving
32 notice thereof upon the other party hereto and filing said

1 notice with the Court;

2 (3) In the event plaintiff withdraws its consent hereto,
3 this Stipulation shall be of no effect whatever in this or any
4 other proceeding and the making of this Stipulation shall not
5 in any manner prejudice any consenting party in any subse-
6 quent proceeding.
