The concepts and features of the consumer PC, including its overall out-of-box experience (OOBE) need to be simple and straightforward i.e. easy to learn and use. They need to be introduced gradually without causing confusion and frustration. Information and assistance need to be available to guide users if and when needed. Meeting or exceeding the consumer PC OOBE will lead to a very positive and productive experience with the PC leading to increased perception of its value, utility and continual use.

Windows 98 OOBE Analysis

The standard Windows 98 first time boot sequence creates a number of usability issues to users.

1. The presence of the channel bar in the desktop will create confusion and frustration when novice users attempt to use it prior to being introduced to the notion of the Internet and prior to signing up with an ISP.

2. The Welcome to Windows dialog box and the extensive procedures a user is exposed to is inconsistent and out-of-step with the rest of the Pavilion system setup. This will also lead to confusion.

3. The Welcome to Windows dialog box forces users to go through multiple steps (sort of as in a wizard) before displaying an "Exit" but the cut of hox experience of

button. This lengthens considerably the out of box experience of novice to intermediate users who might not know about closing windows by clicking the "x" in the top right corner of windows

Basic usability guidelines always recommend offering a clear exit to users

The Welcome to Windows dialog box that appears at the first boot up is accompanied by a background music that certain people could find

offensive (Rolling Stones type of music triat certain people could finoffensive (Rolling Stones type of music with loud breathing sounds.
This is not be appropriate for certain age groups.

5. The Inbox icon on the desktop is unnecessary. Since Windows 98
does not include the Microsoft Fax application, the Inbox can only
be used for e-mail purposes and only if the user has a Microsoft
Mail account, which is suitable in a business environment only. For home use, the Outlook Express Mail and News client that comes with Internet Explorer is much more appropriate.

Windows 98 OOBE Recommendations

For the five reasons stated above, HPD is requesting Microsoft for the following five corresponding exceptions to the standard Windows 98 first time boot sequence.

- 1. Leave the channel bar closed when the user gets to the decided for the first time.
- Allow the Pavilion system set up to run and complete before the appearance of the Welcome to Windwos dialog box.
- 3. Modify the Welcome to Windows dialog to include a clear exit to users
- 4. Eliminate the background music of Welcome to Windows dialog box.
- 5. Eliminate the InBox icon from the desktop. Instead, make it available in some other locaton such as the Online Service folder.

HPD believes strongly that these exceptions to the standard Windows 98 first time boot sequence will lead to a more positive experinece for novice and intermediate users.
