We were surprised when we went to a trade show and saw them demo WHIP! since we didn't really help them set it up although we've been trying real hard (same as the ShockWave folks of course) to do something in their launch.

Since we had originally written it as an OCX last Fall for the NCompass/Excite browser - and now it runs with the NCompass OCX plugin) ago, the Internet Tools and Platforms Division Product Mgr. at MS who used to be an AutoCAD prod. mgr. just tried the raw OCX and it worked, I think. I am not sure whether they are using the plugin ActiveX control or just our OCX.

We need to be on their browser to get the 5% who use it and to kiss the ass of a few MS people who help us sell 3DS and AutoCAD. I am sure NS understands.

But believe me, I'm taking a lot of grief (phone calls, email threats, etc.) from them for working so closely with you guys and doing it with good reason, I feel.
