#### Sherman Act

**Collusive Bidding—Restrictive Practices—Power Transformers—Consent Judgment.**—A consent judgment (1962 TRADE CASES ¶70,504) was modified to permit defendants to itemize total cost for power transformers instead of providing individual cost itemizations for each power transformer covered by bids which include other major equipment.

#### Stipulation

GANEY, Circuit Judge [*In full text*]: Final Judgment having been entered herein on October 1, 1962, and the plaintiff and the defendants signatory hereto desiring to modify subsection (D) of Section VI thereof, it is hereby stipulated that the said subsection be stricken as to the defendants signatory hereto and in lieu thereof a new subsection be inserted as to such defendants to read as follows:

(D) Each consenting defendant is ordered and directed, for a period of ten (10) years from the effective date of this subsection (D), when submitting a bid or quotation for the sale of any power transformer, except rectifier transformers (for which a price is included by such defendant in the calculation of its bid or quotation), combined with other major items or electrical equipment to set forth and itemize separately the total amount included in such bid or quotation for power transformers.
