Pursuant to Rule 60(b) of the Federal Rules of Civil Procedure, the United States moves to terminate the judgment entered on March 19, 1959 in the above-captioned antitrust case that was originally "Civil No. 2150-SD-W." As explained in the accompanying Memorandum in Support of Motion of the United States to Terminate Legacy Antitrust Judgment, the United States, after study, concludes that due to its age and because of likely changed circumstances since its entry, this decades-old judgment no longer serves to protect competition. The United States gave the public notice and the opportunity to comment on its intent to seek termination of the judgment; it received no comments opposing termination. For these and other reasons explained in the accompanying memorandum, the United States requests that this judgment be terminated.
