## UNITED STATES' MOTION TO TERMINATE LEGACY ANTITRUST JUDGMENTS

The United States moves this Court pursuant to Federal Rule of Civil Procedure 60(b) to terminate the judgments in each of the above-captioned antitrust cases. The judgments were entered by this Court between 108 and 42 years ago. The United States has concluded that because of their age and changed circumstances since their entry, these judgments no longer serve to protect competition. The United States gave the public notice and the opportunity to comment on its intent to seek termination of the judgments; it received no comments.

For these and other reasons explained in the accompanying memorandum of law, the United States requests that the judgments be terminated. A proposed order is submitted herewith.
