FINAL DECREE.

This cause came on to be heard at this term, and upon consideration thereof, and upon motion of the petitioner, by Francis G. Caffey, United States Attorney for the Southern District of New York, its attorney, and Henry A. Guiler, Special Assistant to the United States Attorney, and Ryland W. Joyce, Special Assistant to the United States Attorney, of Counsel, for relief in accordance with the prayer of the petition, and all the parties having appeared therein by their attorneys, and having consented thereto in open court:

Now, therefore, it is ORDERED, ADJUDGED AND DECREED as follows, viz.:

That said defendant, its members, officers, agents, servants, employees, and all persons acting under, through, by, or in behalf of it, or claiming so to act, be and hereby are perpetually enjoined, restrained and prohibited directly or indirectly, from

(a) Agreeing to, fixing or establishing in any manner whatsoever, the prices to be charged for said corrugated paper boxes, or maintaining the said prices after they are so agreed to, fixed or established.

(b) Maintaining or continuing to maintain individually or collectively in any manner whatsoever, the prices already agreed upon or adopted.

(c) Agreeing to, fixing, establishing or adopting the terms, discounts, conditions or policies which should obtain with respect to the sale or disposal of said corrugated paper boxes.

(d) Maintaining or continuing to maintain individually or collectively, in any manner whatsoever, the terms, discounts, conditions or policies with respect to the sale or disposal of said corrugated paper boxes already agreed to, fixed, established or adopted.

(e) Agreeing in any manner whatsoever to charge purchasers of said corrugated paper boxes uniform prices, or doing any act which will or may be calculated to result in uniform prices.

(f) Agreeing in any manner whatsoever to advance prices for said corrugated paper boxes or advising or communicating with one another as to proposed advances in prices, or in any way circulating among themselves information concerning or relating to said proposed advances.

(g) Aiding, abetting or assisting, individually or collectively, others to do all or any of the matters or things herein set forth or enjoined.
