Looking back at my e-mails, Ann sent invites for the September and October moots that included a small group of five or six people that included both JP and Caryn. This is our common practice – to invite the regular mooters to see how many are available. I should one note: Tony has done an excellent job of keeping confidential that Caryn has filed a complaint or the reason for her current telework status, so Ann had no idea then (and to my knowledge still has idea now) about the extent of the friction, for lack of a better word, between JP and Caryn. Some people have more or less surmised what is going on by this point, but especially in the beginning several people were under the impression that Caryn was on telework status to deal with a health issue. I mention all of that only to give you an idea of Ann's mindset when she sent those invites – Caryn and JP are both excellent mooters, so Ann would not have thought twice about including both of them on the invite.

The December invite was a bit different. For those moots, Ann sent an e-mail to the entire office seeking volunteers because we were hosting three moots for outside lawyers. One of the three was cancelled, so we ended up hosting two. Caryn participated in one of them by phone. My e-mail indicates that seven total people had planned to participate in that moot, including JP, but I don't have any record of whether he actually participated – I think he did, but I'm not certain.

Finally, for the January moot, Ann did not copy me on the e-mail so I'm not 100% if it was sent to JP and other trial attorneys or just to the three appellate / RW people (Jared, Melissa, and Caryn).
