Caryn,

The matters we discussed yesterday were as follows:

1. Modification of the organizational chart. I will be modifying the organizational chart so as to reflect you will be a part of the Appellate Unit and you will serve under the Appellate Chief Josh Carpenter. Josh Carpenter and the Appellate Unit will be answerable to me.
2. I will be converting you to an Assistant Federal Public Defender upon the Administrative Officer's return to the office on Monday. I advised you I didn't know if the conversion would take place immediately but Bill would be able to tell me on Monday. Either way, the conversion will take place as soon as possible.
3. You requested that you work exclusively on appeals with the Appellate Unit. I advised you I needed to talk with Appellate Chief Josh Carpenter to see what his thoughts were. I have just talked to Josh and he advised he indicated to you in a conversation that he envisioned all three (3) positions (the you, Jared and the new AFD) would all be doing trial and appellate support. He advised you were supportive of the idea. Either way, I agree with Josh and cannot accommodate you on that. It is his position that all of the attorneys in the Appellate Unit should provide trial support and be collaborative in their support of the trial teams.
4. You requested a change in duty station. I advised you I do not have any available office space in Asheville. You then requested telework and I advised you I would look into it but I was not agreeable at this time to the idea. I advised I would report back in one week.
