DOJ environment chief exits with shot at enforcement tool

The departing chief of the Justice Department's environment division, Jeffrey Bossert Clark, took another swing this week at a once popular enforcement tool that fell out of favor in the Trump administration.

Clark issued [explanations](#) of his views on supplemental environmental projects and attempts to "provide practical guidance to Division attorneys considering whether mitigation relief is appropriate."

"Far from limiting mitigation, the memo seeks to encourage its proper use by providing needed clarity about the distinction between permissible mitigation and illegal supplemental environmental projects and by giving ENRD attorneys guidance to ensure that our requests for mitigation relief are consistent with longstanding principles of equity," Clark said in a statement today, his last day as assistant attorney general for DOJ's Environment and Natural Resources Division (ENRD).

DOJ didn't offer further details about Clark's departure, which took effect at noon and comes just under a week before the end of the Trump administration. Principal Deputy Assistant Attorney General Jonathan Brightbill will step in as acting ENRD chief.

This week's memos appear to serve as the final legal justification for doing away with SEPs, which allow polluters to complete EPA-approved projects in exchange for lower fines.

The Biden administration is expected to revive SEPs.

"As a practical matter, [Clark's new memo] will be gone and disregarded in less than a week," said Justin Savage, a partner at Sidley Austin LLP and a former DOJ environment lawyer.

"Jeff is intellectually curious," Savage continued. "He's been working on this for a while. But the next administration will give this no weight."

Clark's parting instruction "just creates additional legal rationale that a successor AAG will need to explain why they're deviating from it," said Kelly Johnson, a partner at Holland & Hart LLP who worked at DOJ during the George W. Bush administration.

Clark, who had served as ENRD chief since 2018, issued a memo last year that said DOJ would no longer use SEPs in civil settlements with private parties ([Greenwire](#), March 13, 2020).

The move puzzled lawyers who said SEPs were largely popular among polluters, DOJ attorneys and EPA.

While Johnson expects SEPs to come back under Biden, she said she would like the new administration to consider making some minor adjustments to the tools.

"My hope would be that the next AAG seeks to have a policy that recognizes the need for some connection between the violation being prosecuted and SEPs," she said.

Among the many legal lifts for the Biden team, reviving SEPs is likely to be one of the easiest to accomplish, Johnson said.

"This is something they will have to explain," she said. "Is it a few more paragraphs in their SEP memo? That's what I would imagine."

Record low EPA enforcement data

News of Clark's memos and his departure come as EPA reported data showing a continued decline in environmental enforcement under the Trump administration.

The data [shows](#) that EPA saw some record low numbers in its enforcement efforts in the fiscal year that ended Sept. 30, 2020.

"EPA's enforcement program deserves credit for what it was able to accomplish during the COVID-19 pandemic, and particularly for its efforts to keep fraudulent disinfectants and 'anti-viral' products out of the marketplace," said Eric Schaeffer, executive director of the Environmental Integrity Project and former director of civil enforcement at EPA.

"But the results released today and over the past four years confirm the long-term decline in federal enforcement of environmental law," Schaeffer continued, "whether compared to the record under the Obama administration or over the past two decades."

Biden's DOJ, which is set to be led by Judge Merrick Garland of the U.S. Court of Appeals for the District of Columbia Circuit, is expected to work with EPA to take a much more aggressive approach to environmental enforcement ([Greenwire](#), Jan. 7).

It is not yet known who will lead ENRD under Biden. Deputy Assistant Attorney General Jean Williams is

currently the division's highest ranking career official.

During Clark's time at DOJ, the department secured some notable environmental settlements, including a landmark \$1.5 billion deal with the maker of Mercedes-Benz cars over claims that the company cheated emissions standards (*E&E News PM*, Sept. 14, 2020).

Clark has argued high-profile cases, including *Juliana v. United States*, in which a group of teenagers and young adults called on the courts to force the federal government to address climate change. Last year, the 9th U.S. Circuit Court of Appeals sided with the government, but not without issuing a strong warning about the imminent threat of global warming.

"Jeff has had some strong successes in his time at ENRD," said Savage. "He is a brilliant lawyer, but I also think it's well known that there's been tension with the career staff on both policy and case management, particularly where he's argued several cases, which has traditionally been done by career folks."

Once Biden takes office, Savage said, he expects DOJ environmental justice and climate issues to rise to the top of the department's priority list.

"I think we'll see strong environmental leadership at DOJ," he said.

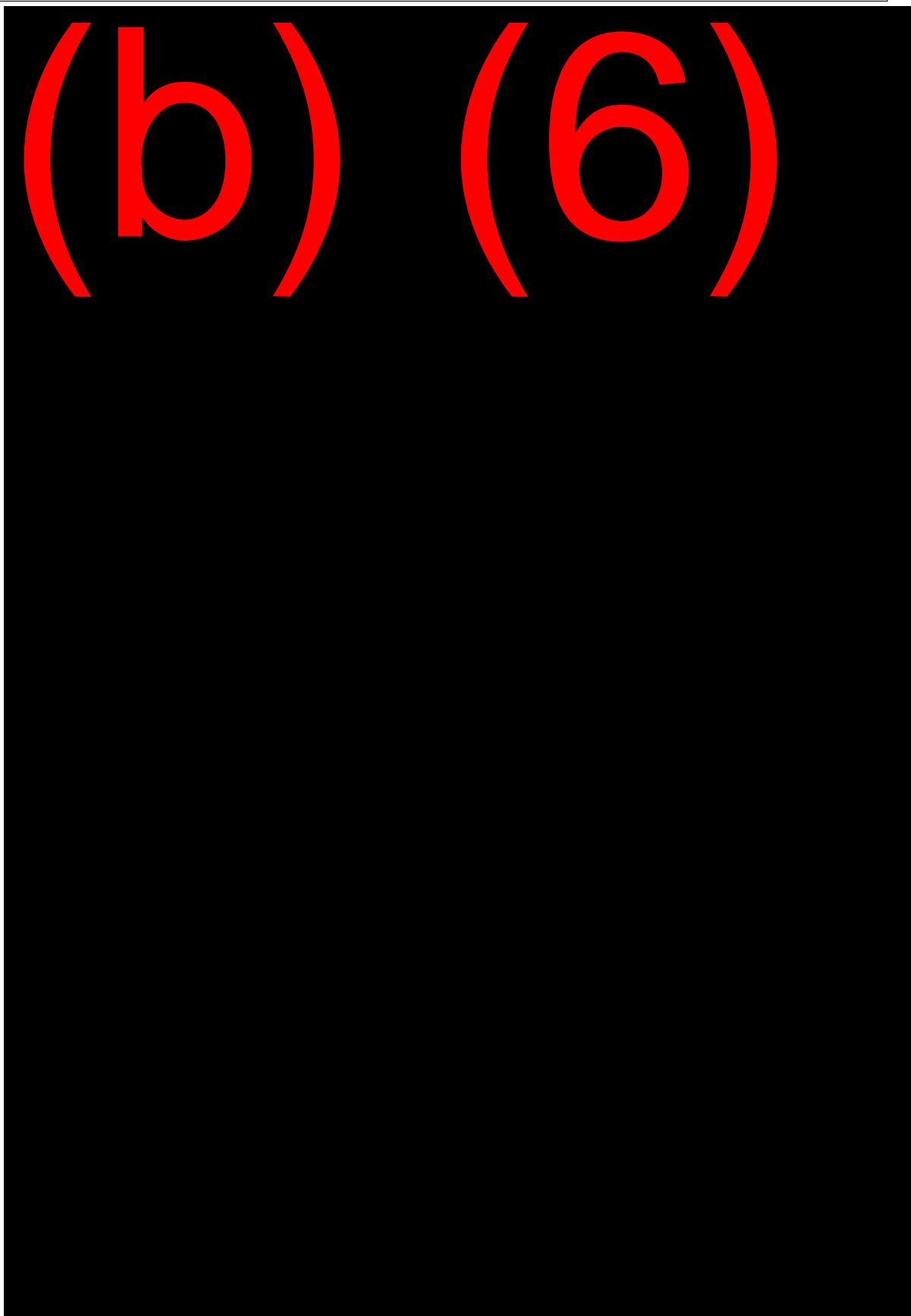
