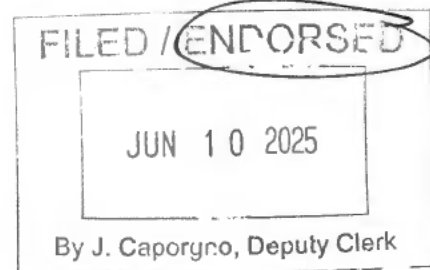

COUNT 1

**Welfare and Institutions Code section 14107, subdivision (a)-a Felony
Presenting False Medi-Cal Claims – 2, 3, or 5 years**

On or about, and between, August 16, 2022 and October 15, 2023, defendant CINDY LYNN FROMM did willfully, unlawfully, and feloniously, with the intent to defraud, presented for allowance or payment any false or fraudulent Medi-Cal claim for furnishing services under the Medi-Cal Act, for money and property of a value exceeding \$950, in violation of Section 14107(a) of the Welfare and Institutions Code, a felony.

COUNT 2


**Penal Code section 550, subdivision (a)(5)-a Felony
Healthcare Insurance Fraud- 2, 3, or 5 years**

On or about, and between, August 16, 2022 and October 15, 2023, defendant CINDY LYNN FROMM did knowingly prepare, make, or subscribe a writing, with the intent to present and use it, and to allow it to be presented in support of false and fraudulent claims, for money and property of a value exceeding \$950, in violation of Penal Code section 550, subdivision (a)(5), a felony.
